PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 15, and shall be read together with and deemed part of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of

their notification in the Gazette.

- 2. Set nets exceeding 1000m, and box or teichi nets, prohibited in defined areas—Regulation 2B (1) of the principal regulations (as inserted by regulation 3 of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended—
 - (a) By omitting from paragraph (b) the words "of Queen Charlotte Sound"
 - (b) By omitting from paragraph (c) the words "of Pelorus Sound".
- 3. Certain fishing prohibited in Pelorus Sound—Regulation 2E (1) of the principal regulations (as inserted by regulation 3 of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended by omitting the words "of inner Pelorus Sound".
- 4. Drag netting prohibited in Queen Charlotte Sound—Regulation 3 (1) of the principal regulations is hereby amended by omitting the words "the Queen Charlotte Sound, being".
- 5. Prohibitions relating to other parts of Queen Charlotte Sound— Regulation 3A (1) of the principal regulations (as substituted by regulation 4 of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended by omitting the words "outer Queen Charlotte Sound, being'
- 6. Trawling prohibited in Queen Charlotte Sound and restricted in Pelorus Sound—Regulation $\tilde{7}$ (1) of the principal regulations is hereby amended by omitting the words "of Pelorus Sound and Queen Charlotte Sound".
- 7. Taking mussels—Regulation 14 of the principal regulations is hereby amended by omitting the words "of Queen Charlotte Sound" in both places where they occur.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in

the Gazette, amend the Fisheries (Challenger Area Commercial Fishing) Regulations 1986.

The purpose of the regulations is to clarify, in the principal regulations, descriptions of the areas known as Queen Charlotte Sound and Pelorus Sound and descriptions of parts of those areas. To that end, references that could have been read as limiting the detailed co-ordinates specified in the various descriptions have been removed.
