PURSUANT to section 89 of the Fisheries Act 1988, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 17, and shall be read together with and deemed part of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1995.

2. Set nets exceeding 1000m, and box or teichi nets, prohibited in defined areas—Regulation 2B (1) of the principal regulations (as inserted by regulation 3 of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended by revoking paragraph (d), and substituting the following paragraph:
"(d) Admiralty Bay: The waters of Admiralty Bay lying inside a straight

line drawn from Collinet Point (at 40° 55.50' S 173° 50.80' E) to Clay Point (at 40° 53.40' S and

173° 58.80′ E):".

3. Trawling prohibited in Queen Charlotte Sound and restricted in Pelorus Sound—Regulation 7 (2) of the principal regulations is hereby amended by omitting the words "Turn Point Light (at 41° 08.7' S and 173° 52′ E) to Penguin Bay Reef (at 41° 08.1′ S and 173° 51.1′ E)", and substituting the words "Tawero Point (at 41° 03.80′ S and 173° 57.0′ E) to Opani-Aputa Point (at 41°04.70′ S and 173° 58.50′ E)".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1995, amend the Fisheries (Challenger Area Commercial Fishing) Regulations 1986.

Regulation 2 corrects the definition of Admiralty Bay in regulation 28 of the principal Regulations.

Regulation 3 amends regulation 7 (2) of the principal regulations (which restricts trawling in the waters of Pelorus Sound) to avoid a conflict with regulation 2E (which prohibits commercial fishermen taking finfish from the inner Pelorus Sound).
