



**THE FISHERIES (SOUTH-EAST AREA COMMERCIAL FISHING)
REGULATIONS 1986, AMENDMENT NO. 18**

PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (South-East Area Commercial Fishing) Regulations 1986, Amendment No. 18, and shall be read together with and deemed part of the Fisheries (South-East Area Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1995.

2. Interpretation—(1) Regulation 2 (1) of the principal regulations (as substituted by regulation 2 (1) of the Fisheries (South-East Area Commercial Fishing) Regulations 1986, Amendment No. 8) is hereby amended by revoking the definition of the term “licensed fish packing house”, and substituting the following definition:

“‘Licensed fish packing house’ means—

“(a) Sanford South Island (Fish Packing House Licence No. 5):

“(b) Globe Export Fisheries Limited (Fish Packing House Licence No. 51):

“(c) Otago Marine Management Limited (Freshwater Fish Farming Licence SF/16):

“(d) Otakou Fisheries Limited (Fish Packing House Licence No. 91):

“(e) Pacifica Fishing Limited (Fish Packing House Licence No. 201):

“(f) Paua Supplies Limited (Fish Packing House Licence No. 313):”.

(2) Regulation 2 of the Fisheries (South-East Area Commercial Fishing) Regulations 1986, Amendment No. 10 is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1995, amend the Fisheries (South-East Area Commercial Fishing) Regulations 1986 by adding to the list of licensed fish packing houses the name Paua Supplies Limited.
