PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 19, and shall be read together with and deemed part of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1996.

2. Taking eels from waters of National Parks—The principal regulations are hereby amended by revoking regulation 14j (as inserted by regulation 7 of the Fisheries (Challenger Area Commercial Fishing) Regulations 1986, Amendment No. 7).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1996, revoke the regulation prohibiting the taking of eels from waters of National Parks within the Challenger Area. This leaves the position of eel-fishing in any particular National Park to be determined under the management plan for that park.
