PURSUANT to section 89 of the Fisheries Act 1988 and sections 297 and 298 of the Fisheries Act 1996, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (South-East Area Commercial Fishing) Regulations 1986, Amendment No. 22, and shall be read together with and deemed part of the Fisheries (South-East Area Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Prohibition on trawling by large vessels in salmon conservation area adjacent to Banks Peninsula—Regulation 4B of the principal regulations (as inserted by regulation 3 of the Fisheries (South-East Area Commercial Fishing) Regulations 1986, Amendment No. 21) is hereby amended by revoking subclause (3).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Fisheries (South-East Area Commercial Fishing) Regulations 1986 by removing the 5-tonne salmon catch limit contained in regulation 4B (3) in relation to trawling by large vessels in the salmon conservation area adjacent to Banks Peninsula.
