



**THE FISHERIES (CENTRAL AREA COMMERCIAL FISHING)
REGULATIONS 1986, AMENDMENT NO. 8**

PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Central Area Commercial Fishing) Regulations 1986, Amendment No. 8, and shall be read together with and deemed part of the Fisheries (Central Area Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Interpretation—(1) Regulation 2 (1) of the principal regulations (as substituted by regulation 2 of the Fisheries (Central Area Commercial Fishing) Regulations 1986, Amendment No. 3) is hereby amended by revoking the definition of the term “set net” (as amended by regulation 2 (1) of the Fisheries (Central Area Commercial Fishing) Regulations 1986, Amendment No. 6), and substituting the following definition:

“‘Set net’ includes a gill net or any other sort of net which acts by enmeshing, entrapping, or entangling any fish; but does not include a fyke net or a hinaki trap:”.

(2) Regulation 2 (1) of the Fisheries (Central Area Commercial Fishing) Regulations 1986, Amendment No. 6 is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, amend the Fisheries (Central Area Commercial Fishing) Regulations 1986 by excluding fyke nets and hinaki traps from the definition of the term “set net”.
