### THE FOOD AND DRUG REGULATIONS 1946, AMENDMENT NO. 15

# ARTHUR PORRITT, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 5th day of August 1968

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Food and Drugs Act 1947, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Food and Drug Regulations 1946, Amendment No. 15, and shall be read together with and deemed part of the Food and Drug Regulations 1946\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the fourteenth day

after the date of their notification in the Gazette.

2. Preservatives for fruit juice—Regulation 159 of the principal regulations is hereby amended by revoking clause (4), and substituting the following clause:

"(4) Notwithstanding anything in clause (3) of regulation 27 of these regulations, the following preservative substances may be added to fruit

- "(a) Sulphur dioxide (or sulphites calculated as sulphur dioxide), in proportion not exceeding 250 parts per million by weight; or
- "(b) Benzoic acid (or sodium benzoate calculated as benzoic acid), in proportion not exceeding 1,000 parts per million by weight; or
- "(c) Sorbic acid (or potassium sorbate calculated as sorbic acid), in proportion not exceeding 1,000 parts per million by weight;

"(d) Any combination of any of the preservative substances mentioned

in paragraphs (a) to (c) of this clause:

"Provided that the amount of each such substance is such that when it is expressed as a percentage of the amount permitted singly the sum of the several percentages does not exceed 120."

3. Preservatives for fruit syrups—Regulation 161 of the principal regulations is hereby amended by revoking clause (4), and substituting the following clause:

"(4) Notwithstanding anything in clause (3) of regulation 27 of these regulations, the following preservative substances may be added to fruit

"(a) Sulphur dioxide (or sulphites calculated as sulphur dioxide), in proportion not exceeding 350 parts per million by weight; or

"(b) Benzoic acid (or sodium benzoate calculated as benzoic acid), in proportion not exceeding 1,000 parts per million by weight; or

"(c) Sorbic acid (or potassium sorbate calculated as sorbic acid), in proportion not exceeding 1,000 parts per million by weight; or

"(d) Any combination of any of the preservative substances mentioned

in paragraphs (a) to (c) of this clause:

'Provided that the amount of each such substance is such that when it is expressed as a percentage of the amount permitted singly the sum of the several percentages does not exceed 120."

4. Preservatives for fruit non-fermented beverages—Regulation 167 of the principal regulations is hereby amended by revoking clause (2), and substituting the following clause:

"(2) Notwithstanding anything in clause (3) of regulation 27 of these regulations, the following preservative substances may be added to fruit

non-fermented beverages:

"(a) Sulphur dioxide (or sulphites calculated as sulphur dioxide), in proportion not exceeding 115 parts per million by weight; or

"(b) Benzoic acid (or sodium benzoate calculated as benzoic acid), in proportion not exceeding 400 parts per million by weight; or

"(c) Sorbic acid (or potassium sorbate calculated as sorbic acid), in proportion not exceeding 400 parts per million by weight; or

"(d) Any combination of any of the preservative substances mentioned

in paragraphs (a) to (c) of this clause:

"Provided that the amount of each such substance is such that when it is expressed as a percentage of the amount permitted singly the sum of the several percentages does not exceed 120.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Food and Drug Regulations 1946 by substituting new requirements in respect of the preservative substances which may be added to fruit juice, fruit syrups, and fruit non-fermented beverages. The preservative substances permitted to be added at present are sulphur dioxide or sodium benzoate or sorbic acid, but under the new requirements any combination of these substances may be added within the prescribed limits.
