



**THE FISHERIES (AUCKLAND AND KERMADEC AREAS
AMATEUR FISHING) REGULATIONS 1986, AMENDMENT NO. 6**

ORDER IN COUNCIL

PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986, Amendment No. 6, and shall be read together with and deemed part of the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Set netting prohibited in defined areas—(1) Regulation 6c of the principal regulations (as inserted by regulation 4 of the Fisheries (Auckland

and Kermadec Areas Amateur Fishing) Regulations 1986, Amendment No. 3) is hereby amended by revoking paragraph (i), and substituting the following paragraph:

“(i) *Cape Colville*: The waters at the northern end of Cape Colville lying inside a line commencing at the northernmost extremity of Kaiiti Point (at $36^{\circ} 28.92'S$ and $175^{\circ} 19.80'E$); then in a straight line in a northerly direction to the southernmost extremity of Channel Island (at $36^{\circ} 25.44'S$ and $175^{\circ} 19.75'E$); then in a straight line in a south-easterly direction to the northernmost extremity of Square Top Island (at $36^{\circ} 27.76'S$ and $175^{\circ} 24.00'E$); then by the mean high-water mark to the easternmost extremity of Square Top Island (at $36^{\circ} 27.79'S$ and $175^{\circ} 24.14'E$); then in a straight line in a south-easterly direction to the mean high-water mark to the south-west of, and immediately adjacent to, the Sugar Loaf Rocks (at $36^{\circ} 28.36'S$ and $175^{\circ} 24.69'E$); then by the mean high-water mark in a generally north-westerly direction to a point to the south of Cape Colville, representing the eastern end of Port Jackson Bay (at $36^{\circ} 28.40'S$ and $175^{\circ} 20.45'E$); then by a straight line across the bay in a generally south-westerly direction to the point of commencement.”

(2) Regulation 6c of the principal regulations (as so inserted) is hereby further amended by adding the following paragraph:

“(m) *Tairua/Pauanui*: The waters inside an area defined by a line beginning at the mean high-water mark at the northernmost point of Storm Beach (at $37^{\circ} 02.77'S$ and $175^{\circ} 53.23'E$); then in a straight line in a generally easterly direction to a position at the southernmost point of Home Bay (at $37^{\circ} 03.11'S$ and $175^{\circ} 56.05'E$); then in a straight line in a generally northerly direction to Big King Rock (at $36^{\circ} 59.92'S$ and $175^{\circ} 55.34'E$); then by a straight line in a generally north-westerly direction to the mean high-water mark at the northern end of Te Karo Bay (at $36^{\circ} 57.70'S$ and $175^{\circ} 50.75'E$); then following the mean high-water mark in a southerly direction to the southernmost point of land near Te Huruuru Point (at $37^{\circ} 00.40'S$ and $175^{\circ} 52.10'E$); then in a straight line across the Tairua harbour entrance in a south-westerly direction to the northernmost point of land of the southern harbour headland (at $37^{\circ} 00.45'S$ and $175^{\circ} 51.70'E$); then following the mean high-water mark in a generally southerly direction to the point of commencement.”

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, amend the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986 by—

- (a) Prohibiting amateur set netting in the vicinity of Tairua and Pauanui; and
- (b) Removing the inner waters of Port Jackson Bay from the Cape Colville amateur set net closed area.
