

# THE FISHERIES (AUCKLAND AND KERMADEC AREAS **COMMERCIAL FISHING) REGULATIONS 1986, AMENDMENT** NO. 6

#### ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Fisheries (Auckland and Kermadec Areas Commercial Fishing) Regulations 1986, Amendment No. 6, and shall be read together with and deemed part of the Fisheries (Auckland and Kermadec Areas Commercial Fishing) Regulations 1986\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. Restrictions on fishing within 1 nautical mile of Mayor (Tuhua) Island—The principal regulations are hereby amended by inserting, after regulation 18A, (as inserted by the Fisheries (Auckland and Kermadec Areas Commercial Fishing) Regulations 1986, Amendment No. 3), the following regulation:

<sup>74</sup>18AA. No commercial fisherman shall use for fishing a set net or longline within 1 nautical mile seaward of the mean high-water mark of the

coast of Mayor (Tuhua) Island."

**3. Restrictions on taking of shellfish**—(1) Regulation 22A (1) of the principal regulations (as substituted by regulation 7 of the Fisheries (Auckland and Kermadec Areas Commercial Fishing) Regulations 1986, Amendment No. 3), is hereby amended by omitting the item relating to scallops in the table set out in that provision.

(2) Regulation 22A (2) of the principal regulations (as so substituted) is hereby amended by omitting the words "notwithstanding subclause (1) of

this regulation, it", and substituting the word "It".

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in the Gazette, amend the Fisheries (Auckland and Kermadec Areas Commercial Fishing) Regulations 1986.

The amendments are as follows:

(a) Regulation 2 prohibits the use by commercial fishermen of set nets or longlines in the waters lying within 1 nautical mile of Mayor (Tuhua) Island:

(b) Regulation 3 removes the daily landing limit of 600 kg (greenweight) of scallops that a commercial fisherman may take from the Coromandel Fishery area during the open scallop season. The amount of scallops a commercial fisherman may in future take from the Coromandel Fishery area during the open scallop season will be specified as a maximum quota condition on the fishing permits granted to any commercial fisherman under the Fisheries Act 1983.
