## THE FRUIT AND PLANTS IMPORTATION AMENDING REGULATIONS 1949

Pursuant to the Orchard and Garden Diseases Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS

- 1. These regulations may be cited as the Fruit and Plants Importation Amending Regulations 1949.
- 2. These regulations shall be read together with and deemed part of the regulations made under the Orchard and Garden Diseases Act, 1908, on the 23rd day of August, 1915, and published in the Gazette on the 2nd day of September, 1915, at page 3100, and enuring under the Orchard and Garden Diseases Act, 1928 (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the seventh day following notification in the *Gazette* of the making thereof.
- 4. Clause 7 of the principal regulations and the subheading thereto (as substituted by Clause 2 of amending regulations made under the Orchard and Garden Diseases Act, 1908, on the 22nd day of February, 1926, and published in the *Gazette* on the 4th day of March, 1926, at page 529) are hereby revoked and the following subheading and clause substituted:—
- "Grape-vines and Portions Thereof (Except Grapes), Hop-sets or Cuttings of any Variety of Hop-plant and Raspberry-plants and Portions Thereof, Including Raspberries
- "7. The Director of the Horticulture Division of the Department of Agriculture may, with the approval of the Minister of Agriculture, introduce or grant permission in writing to any person to introduce into New Zealand from any country or place grape-vines of special varieties or portions thereof, hop-sets of any variety of hop-plants and raspberry-plants or portions thereof, including the fruit, subject to such conditions as the Director with the like approval may impose."
- 5. The subheading to clause 8 of the principal regulations is hereby revoked, and the following subheading substituted: "Plants or Portions Thereof Other Than Those Mentioned in Clause 7"

- 6. Clause 8 of the principal regulations is amended by revoking the words "except grape-vines or portions thereof," and substituting the words "other than the plants or portions thereof mentioned in Clause 7 hereof."
- 7. Clause 2 of the said amending regulations made on the 22nd day of February, 1926, is hereby consequentially revoked.
- 8. The Order in Council prohibiting the introduction into New Zealand of hop-sets of any variety of hop-plants made on the 11th day of November, 1929, and published in the *Gazette* on the 14th day of the same month, at page 2876, is hereby consequentially revoked.
