

FISHERIES (REPORTING) AMENDMENT REGULATIONS (NO. 2) 1997

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 89 of the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Fisheries (Reporting) Amendment Regulations (No. 2) 1997, and are part of the Fisheries (Reporting) Regulations 1990* ("the principal regulations").
 - (2) These regulations come into force on 1 February 1998.
- 2. Use of codes for certain entries—Regulation 20 (3) (h) of the principal regulations is amended by revoking subparagraph (i), and substituting the following subparagraph:

"(i) The Lake Ellesmere eel fishery (as defined in the Fisheries (Lake Ellesmere Eel Quota) Regulations 1997*); and".

3. Fishstock and species codes—(1) Part I of the Second Schedule of the principal regulations is amended by inserting in the first, second, and fourth columns in Table 1, after the item relating to ling, the following item:

(2) Part I of the Second Schedule of the principal regulations is amended by inserting in the first, second, and fourth columns in Table 1, immediately before the item relating to silver warehou, the following item:

- (3) Part I of the Second Schedule of the principal regulations is amended by inserting in note 2 of Table 2 (as substituted by regulation 2 (2) of the Fisheries (Reporting) Regulations 1990, Amendment No. 4), in their appropriate alphabetical order, the following definitions:
 - "'Ellesmere' means the Lake Ellesmere area as defined in regulation 2 of the Fisheries (Lake Ellesmere Eel Quota) Regulations 1997:
 - "'Part South-East (Coast)' means that part of Quota Management Area 3—South-East (Coast) that is not included in Ellesmere:".
- (4) Part I of the Second Schedule of the principal regulations is amended by inserting in Table 2, before the item "South-East (Chatham Rise)", the following items:

"Part South-East (Coast)	 	 	3D
"Ellesmere		 	 	3E".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend regulation 20 of the Fisheries (Reporting) Regulations 1990, which deals with codes and maps, and also the codes in the Second Schedule of those regulations, to reflect the fact that from 1 February 1998 the Lake Ellesmere eel fishery ceases to be a controlled fishery.
