



## THE FOREST AND RURAL FIRES LEVY NOTICE 1989

PURSUANT to section 60B of the Forest and Rural Fires Act 1977, the Minister of Forestry hereby gives the following notice.

### NOTICE

**1. Title and application**—(1) This notice may be cited as the Forest and Rural Fires Levy Notice 1989.

(2) This notice shall apply to the rates of annual levy payable for the year commencing on the 1st day of April 1988 and the 1st day of April 1989.

**2. Rates of levy for year commencing 1 April 1988**—The rates of levy prescribed for the year commencing on the 1st day of April 1988 shall be as follows:

- (a) In respect of each Fire Authority having territorial jurisdiction over a county area, 0.2 cents per hectare on land administered by the Fire Authority on the 1st day of April 1988:
- (b) In respect of the Fire Authority, being the Minister of Defence, administering a rural fire district, 1.4 cents per hectare on land administered by the Fire Authority on the 1st day of April 1988:
- (c) In respect of each Fire Authority, other than the Minister of Defence, that administers a rural fire district under section 4 of the Forest and Rural Fires Act 1977,—
  - (i) 1.4 cents per hectare on land used solely or principally for the purposes of recreation, conservation, water-catchment, and other related non-commercial rural activities, and administered by the Fire Authority on the 1st day of April 1988:
  - (ii) 2.8 cents per hectare on all other land administered by the Fire Authority on the 1st day of April 1988:
- (d) In respect of the Fire Authority, being the Minister of Conservation, that administers a State area, 0.61 cents per hectare on land administered by the Fire Authority on the 1st day of April 1988:
- (e) In respect of the Fire Authority (being the New Zealand Forestry Corporation Limited) administering the New Zealand Forestry Corporation Rural Fire District, 1.4 cents per hectare on land administered by the Fire Authority on the 1st day of April 1988.

**3. Minimum amount payable by Fire Authority for year commencing 1 April 1988**—The minimum amount payable by every

Fire Authority in respect of the levy for the year commencing on the 1st day of April 1988 shall be \$100.

**4. Rates of levy for year commencing 1 April 1989**—The rates of levy prescribed for the year commencing on the 1st day of April 1989 shall be as follows:

- (a) In respect of each Fire Authority having territorial jurisdiction over a county area, 0.4 cents per hectare on land administered by the Fire Authority on the 1st day of April 1989:
- (b) In respect of the Fire Authority, being the Minister of Defence, administering a rural fire district, 2.4 cents per hectare on land administered by the Fire Authority on the 1st day of April 1989:
- (c) In respect of each Fire Authority, other than the Minister of Defence, that administers a rural fire district under section 4 of the Forest and Rural Fires Act 1977,—
  - (i) 2.4 cents per hectare on land used solely or principally for the purposes of recreation, conservation, water-catchment, and other related non-commercial rural activities, and administered by the Fire Authority on the 1st day of April 1989:
  - (ii) 4.7 cents per hectare on all other land administered by the Fire Authority on the 1st day of April 1989:
- (d) In respect of the Fire Authority, being the Minister of Conservation, that administers a State area, 1.04 cents per hectare on land administered by the Fire Authority on the 1st day of April 1989:
- (e) In respect of the Fire Authority (being the New Zealand Forestry Corporation Limited) administering the New Zealand Forestry Corporation Rural Fire District, 2.4 cents per hectare on land administered by the Fire Authority on the 1st day of April 1989.

**5. Minimum amount payable by Fire Authority for year commencing 1 April 1989**—The minimum amount payable by every Fire Authority in respect of the levy for the year commencing on the 1st day of April 1989 shall be \$100.

EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice sets out the rates of the levy payable under section 60A of the Forest and Rural Fires Act 1977.

Clause 2 sets out the rates of levy payable for the year commencing on the 1st day of April 1988 in respect of the various types of Fire Authorities, and clause 4 sets out the rates of levy for the year commencing on the 1st day of April 1989.

There is a minimum amount of \$100 payable by a Fire Authority in respect of each of those years.
