

# FISHERIES (SOUTHLAND AND SUB-ANTARCTIC AREAS COMMERCIAL FISHING) AMENDMENT REGULATIONS 1997

PURSUANT to section 89 of the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following regulations.

### **REGULATIONS**

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Amendment Regulations 1997, and are part of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986\* ("the principal regulations").

(2) These regulations come into force on 1 June 1997.

2. Oyster season and quotas—(1) The principal regulations are amended by revoking regulation 7 (as substituted by regulation 2 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 22).

(2) The Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 22 (S.R. 1996/81) are

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations revoke regulation 7 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, which imposes restrictions on the Foveaux Strait dredge oyster fishery. The restrictions are no longer needed after 1 June 1997, when the oysters come under an individual quota management regime (see the Fisheries (1997 Foveaux Strait Dredge Oyster Quota) Regulations 1997).
