PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 10, and shall be read together with and deemed part of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of May 1991.

- 2. Concession relating to female rock lobster taken between 1 May 1990 and 30 April 1992—(1) Regulation 5c of the principal regulations (as inserted by regulation 3 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 6) is hereby amended by omitting from paragraph (a) the expression "1991", and substituting the expression "1992".
- (2) For the purposes of regulation 5c (1) (d) of the principal regulations, a female rock lobster taken between the 1st day of May 1991 and the 30th day of April 1992 may be measured—
 - (a) By means of a tail-width measuring device referred to in regulation 5D (2) of the principal regulations, notwithstanding that the device is inscribed with the words "Invalid after 30 April 1991"; or
 - (b) By means of a tail-width measuring device, supplied by the Director-General, of similar description to that depicted in the First Schedule to the Fisheries (Commercial Fishing) Regulations 1986*, but showing the expression "57F" instead of the expression "58F" on the relevant arm of the device, and inscribed with the words "Invalid after 30 April 1992".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations extend to 30 April 1992 the 57mm size concession for female rock lobsters taken in the Southland Concession Area.

Female rock lobster taken on or before that date may continue to be measured with the measuring device applying to the period 1 May 1990 to 30 April 1991, notwithstanding that the device is inscribed with the words "Invalid after 30 April 1991".
