# ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 15, and shall be read together with and deemed part of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of November 1992.

Targeting of certain fish, aquatic life, and seaweed prohibited, unless specially authorised—(1) Regulation 15cA (5) of the principal regulations (as substituted by regulation 3 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended by omitting from Part A of the Table of prohibited target species the item "\*Kina (QMA 6)", and substituting the item "\*Kina".

(2) Regulation 15CA (5) of the principal regulations (as so substituted) is hereby amended by omitting from Part A of the Table of prohibited target species the words "\*Prohibition applies to kina in QMA 6 only", and substituting the following words:

"\*Prohibition applies only to kina in QMA 6 and to kina in the waters within 2 nautical miles of the mean high water mark between lines extending two nautical miles seaward of Oliver Point (45°34.7'S, 166°40.7'E) on a true bearing of 315°T and 2 nautical miles seaward of Puysegur Point (46°10.1'S, 166°37.8'E) on a true bearing of 270°T, which includes all the waters of Breaksea Sound, Acheron Passage, Wet Jacket Arm, Dusky Sound, Chalky Inlet, Edwardson Sound, Cunaris Sound, Long Sound, and Preservation Inlet".

**3.** Species that may be taken subject to competitive or individual quotas, method restrictions, etc.—(1) Regulation 15<sub>CB</sub> of the principal regulations (as substituted by regulation 5 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 11) is hereby amended by omitting the item "kina" from the second column of the Table set out in that regulation, and substituting the item "kina".

(2) Regulation 15cB of the principal regulations (as so substituted) is hereby amended by inserting, at the foot of the Table set out in that regulation, the following words:

"\*Authorisation applies to the waters of QMA 5 other than the waters described in the Table set out in regulation 15cA (5) of these regulations."

**4. Kina season and quotas**—Regulation 15F(1) of the principal regulations (as inserted by regulation 6 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 7) is hereby amended by inserting, after the expression "quota management area 5", the words "(other than the waters described in the Table set out in regulation 15cA(5) of these regulations)".

### Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 15

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 November 1992, amend the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986 to implement a kina development programme in Dusky Sound, Fiordland. This is achieved by listing in Part A of the Table of Prohibited Target Species (set out in regulation 15CA (5) of the principal regulations) kina taken from the development area.

Kina may be taken from the new defined area only under a special authorisation under regulation  $15_{CA}$  (2) of the principal regulations.
