PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 16, and shall be read together with and deemed part of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of May 1993.

- 2. Concession relating to female rock lobster taken between 1 May 1993 and 31 March 1994—Regulation 5c of the principal regulations (as inserted by regulation 3 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 6 and as amended by regulation 3 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 12), is hereby amended by omitting the expression "30th day of April 1993", and substituting the expression "31st day of March 1994".
- **3. Revocation**—Regulation 3 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 12 is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 May 1993, amend the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986 by extending until 31 March

and Sub-Antarctic Areas Commercial Fishing) Regulations 1986 by extending until 31 March 1994 the Southland concession for female spiny rock lobster. Presently, such lobsters must have a tail width of at least 57 mm before they can lawfully be taken. The size restriction applying in other areas is 60 mm.
