HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 89 of the Fisheries Act 1996, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 22, and shall be read together with and deemed part of the Fisheries (Southland and Sub-Antarctic Areas

Commercial Fishing) Regulations 1986\* (hereinafter referred to as the principal regulations).

(2) Subject to subclause (3) of this clause, these regulations shall come into force on the day after the date of their notification in the *Gazette*.

(3) Regulation 3 of these regulations shall come into force on the 28th day after the date of notification of these regulations in the *Gazette*.

**2. Species that may be taken subject to competitive or individual quotas, method restrictions, etc.**—Regulation 15CB (1) of the principal regulations (as inserted by regulation 5 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 11) is hereby amended by omitting the words “Jack mackerel”.

**3. New Schedule substituted**—(1) The principal regulations are hereby amended by revoking the Schedule to the principal regulations, and substituting the Schedule set out in the Schedule to these regulations.

(2) Regulation 6 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 6, regulation 8 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 7, and regulation 4 of the Fisheries (Southland and Sub-Antarctic Areas Commercial Fishing) Regulations 1986, Amendment No. 9, are hereby consequentially revoked.
