ORDER IN COUNCIL

At Wellington this 10th day of July 1995

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 54B (1) of the Fisheries Act 1983, Her Excellency the Governor-General, acting on the recommendation of the Minister of Fisheries, and by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Fisheries (Palliser Bay Taiapure) Order 1995.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Palliser Bay taiapure constituted—The New Zealand fisheries waters (being estuarine or littoral coastal waters) described in the Schedule to this order are hereby declared to be a taiapure-local fishery.

SCHEDULE

PALLISER BAY TAIAPURE

Te Kopi

The waters contained within a line commencing at the mouth of the Hurupi Stream at $41^{\circ} 26.55'S$ and $175^{\circ} 12.91'E$ and proceeding in a westerly direction to a point at $41^{\circ} 26.65'S$ and $175^{\circ} 12.40'E$, then proceeding in a generally southerly direction at a distance of 800 metres from the mean high water mark to a point at $41^{\circ} 27.80'S$ and $175^{\circ} 12.50'E$, then proceeding in an easterly direction to the mouth of Twin Creeks at $41^{\circ} 27.85'S$ and $175^{\circ} 13.08'E$, then proceeding along the mean high water mark to the point of commencement.

Te Kumenga

The waters contained within a line commencing at the mouth of the Makotukuku Stream at $41^{\circ} 29.81'S$ and $175^{\circ} 12.42'E$ and proceeding in a westerly direction to a point at $41^{\circ} 29.82'S$ and $175^{\circ} 12.25'E$, then proceeding in a generally southerly direction at a distance of 300 metres from the mean high water mark to a point at $41^{\circ} 31.75'S$ and $175^{\circ} 11.60'E$, then proceeding in an easterly direction to a point at Te Humenga Point at $41^{\circ} 31.70'S$ and $175^{\circ} 11.70'E$, then proceeding along the mean high water mark to the point of commencement.
