



**THE FORESTRY (EAST COAST) GRANTS REGULATIONS 1992,
AMENDMENT NO. 7**

PURSUANT to section 72 of the Forests Act 1949, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Forestry (East Coast) Grants Regulations 1992, Amendment No. 7, and shall be read together with and deemed part of the Forestry (East Coast) Grants Regulations 1992* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Time for application for approval certificate—Regulation 6 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:

“(2) In respect of any subsequent year,—

- “(a) Applications for approval certificates relating to areas of 50 hectares or more shall be lodged with the Secretary before the close of the 30th day of April preceding the calendar year in which the initial work under the forest management plan supplied with the application is intended to be carried out:
- “(b) Applications for approval certificates relating to areas of less than 50 hectares shall be lodged with the Secretary before the close of the 30th day of June preceding the calendar year in which the initial work under the forest management plan supplied with the application is intended to be carried out.”

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after the date of their notification in the *Gazette*, amend the Forestry (East Coast) Grants Regulations 1992.

The purpose of the amendment is to provide for different closing dates for applications for approval certificates under the principal regulations. Formerly, applications had to be lodged before the close of the month of April preceding the calendar year in which the initial work under the forest management plan supplied with the application was intended to be carried out. That requirement will continue to apply in the case of areas of or over 50 hectares. In the case of areas of less than 50 hectares, the closing date is extended to the close of the month of June preceding the calendar year in which that work is intended to be carried out.
