# **Notice**

#### 1 Title

This notice is the Fisheries (Remaining Cost Recovery Settlement Balance) Notice 2006.

#### 2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

### 3 Interpretation

In this notice, unless the context otherwise requires,—

Act means the Fisheries Act 1996

**remaining balance**, in relation to a stock or grouping and the cost recovery sum allocated to the stock or grouping under Schedule 9A of the Act, has the meaning given to it by section 265A(6) of the Act.

# 4 Remaining balance

The remaining balance for each affected stock or grouping as at the date of the commencement of this notice is the amount stated for that stock or grouping in the final column of the Schedule to this notice.
