



**FISHERIES (LAKE ELLESMERE EEL QUOTA ALLOCATION)  
NOTICE 1997**

PURSUANT to regulation 4 of the Fisheries (Lake Ellesmere Eel Quota) Regulations 1997\*, the Minister of Fisheries gives the following notice.

NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Lake Ellesmere Eel Quota Allocation) Notice 1997.

(2) This notice comes into force on 1 February 1998.

**2. Allocation of eel quota**—(1) The quota imposed by regulation 3 of the Fisheries (Lake Ellesmere Eel Quota) Regulations 1997 on the taking of eels in the Lake Ellesmere eel fishery is allocated as set out in the Schedule of this notice.

(2) Not more than 2% of the catch entitled to be taken under each allocation may be long-finned freshwater eels.

EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice allocates the quota set for the Lake Ellesmere eel fishery by the Fisheries (Lake Ellesmere Eel Quota) Regulations 1997.

The quota is allocated to—

- (a) All those individual fishers who held a controlled fishery licence in the eel fishery immediately before it ceased to be a controlled fishery by virtue of the Fisheries (Lake Ellesmere Eel Fishery) Decontrolling Order 1997; and
- (b) Athlone Enterprises Limited on behalf of the Treaty of Waitangi Fisheries Commission.
