ORDER IN COUNCIL

At the Government House at Wellington this 12th day of December 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Forests Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Forestry Encouragement Grants Regulations 1970, Amendment No. 2, and shall be read together with and deemed part of the Forestry Encouragement Grants Regulations 1970* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of January

1978.

2. Interpretation—Regulation 2 of the principal regulations is hereby amended—

(a) By omitting from the definition of the term "landholder" in subclause (1) (a) and 1 (b) the expression "\$200,000", and substituting the expression "\$300,000":

(b) By inserting in paragraph (a) of the definition of the term "land-holding", after the words "under these regulations", the words

"or, in any case to which regulation 4 (2) of these regulations applies, under the Forestry Encouragement Loan Regulations 1967".

3. Eligibility—(1) Regulation 4 of the principal regulations (as amended by regulation 3 of the Forestry Encouragement Grants Regulations 1970, Amendment No. 1) is hereby further amended by inserting, before the words "Subject to these regulations", the expression "(1)".

(2) Regulation 4 of the principal regulations (as so amended) is hereby further amended by adding, as subclause (2), the following subclause:

"(2) Subject to these regulations every landholder who,—

"(a) Is an owner (other than a local authority) within the meaning of the Forestry Encouragement Loans Regulations 1967; and

"(b) Has had remitted the total principal sum and interest owing on any loan made to him in respect of any secured area pursuant to the Forestry Encouragement Act 1962 and regulation 8A of the Forestry Encouragement Loans Regulations 1967,—

shall be eligible for and entitled to receive forestry encouragement grants

under these regulations:

"Provided that the total grant limit prescribed by these regulations in respect of the landholder shall be proportionately reduced by an amount equal to the amount of the principal sum so remitted."

- 4. First Schedule—The principal regulations are hereby further amended by revoking the First Schedule (as substituted by regulation 5 of the Forestry Encouragement Grants Regulations 1970, Amendment No. 1), and substituting the new First Schedule set out in the Schedule to these regulations.
- 5. Second Schedule—The Second Schedule to the principal regulations (as amended by regulation 6 of the Forestry Encouragement Grants Regulations 1970, Amendment No. 1) is hereby further amended by omitting the expression "\$25", and substituting the expression "\$40"

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the qualifications for forestry encouragement grants by amending the definition of the term "landholder", and by enabling persons who have obtained private sector forestry encouragement loans to obtain grants in the place of the loans. New maximum grant and fencing cost limits are provided for.
