## THE FIRE ENGINEERS' QUALIFICATION NOTICE 1983

---

PURSUANT to section 91 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

### NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Fire Engineers' Qualification Notice 1983.

(2) This notice shall come into force on the 1st day of June 1983.

**2. Fire Engineers' Qualification**—Possession of one or more of the qualifications set out in any of clauses 1 to 4 of the Schedule to this notice is hereby declared to be sufficient for the purposes of complying with section 91 of the Fire Service Act 1975.

**3. Revocation**—The Fire Engineers' Qualification Notice 1976\* is hereby revoked.

### SCHEDULE

#### QUALIFICATIONS SUFFICIENT TO COMPLY WITH SECTION 91 OF THE FIRE SERVICE ACT 1975

1. A fellow or member of the Institution of Fire Engineers' (Registered in Scotland No. 13267) who holds a Certificate of Membership of the Institution in the classes set out in clauses 1 and 2 of the Schedule of Bylaws of the Institution and who is able to produce evidence of 4 years' practice in the field of fire engineering subsequent to obtaining that Certificate.

2. A holder of a New Zealand Certificate in Fire Technology NZCE (Fire) issued under the Authority for Advanced Vocational Awards who is able to produce evidence of 4 years' practice in the field of fire engineering subsequent to obtaining that Certificate.

3. A corporate member of the Institution of Professional Engineers New Zealand incorporated in 1914 under the Incorporated Societies Act 1908 as the New Zealand Society of Civil Engineers, who is able to produce

evidence of 4 years' practice in the field of fire engineering after the completion of the relevant academic qualifications for admission to that Institution.

4. A person who, before the 1st day of June 1983, possessed one or more of the qualifications set out in the Fire Engineers' Qualification Notice 1976\*.

This notice revises the qualifications which entitle the holder to use publicly, in connection with his business, trade, calling, or profession, any written words intended or likely to cause any person to believe that he is a fire engineer without committing an offence under section 91 of the Fire Service Act 1975.
