

# FRESHWATER FISH FARMING AMENDMENT REGULATIONS 1997

#### ORDER IN COUNCIL

PURSUANT to sections 89 and 91 of the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Freshwater Fish Farming Amendment Regulations 1997, and are part of the Freshwater Fish Farming Regulations 1983\* ("the principal regulations").
  - (2) These regulations come into force on 1 October 1997.
- **2. Annual licence fee revoked**—Regulation 15 of the principal regulations is revoked.
- **3. Fees**—(1) The principal regulations are amended by revoking the Schedule (as added by regulation 4 of the Freshwater Fish Farming Regulations 1983, Amendment No. 4), and substituting the Schedule set out in the Schedule of these regulations.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 1997, prescribe fees in respect of various matters relating to fish-farm licences.

The annual licence fee previously specified in regulation 15 of the principal regulations is removed.

The other fees specified in the Schedule of the principal regulations are increased, with the one exception of the fee for applications for variations of the conditions of a fish-farm licence. These other fees relate to applications for the issue and renewal of fish-farm licences, and for various approvals, authorities, and consents granted under the principal regulations.
