PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Freshwater Fisheries Local Regulations Revocation Order 1951.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The regulations and notices specified in the Schedule to this order are hereby revoked.

EXPLANATORY NOTE

[*This note is not part of the order, but is intended to indicate its general effect.*]
