THE FISHERIES (SEA FISHING) NOTICE 1984

PURSUANT to section 89 of the Fisheries Act 1983, and to the Fisheries (Commercial Fishing) Regulations 1983, the Minister of Fisheries hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (Sea Fishing) Notice 1984.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Interpretation—(1) In this notice, unless the context otherwise requires,—

- "Albacore tuna" means the fish of which the scientific name is *Thunnus alalunga*:
- "Barracouta" means the fish of which the scientific name is *Thyrsites* atun:
- "Bottom longlining" includes the use of any line or lines (whether baited or not) which are set, moored, or placed on or near the bottom of the sea, and that are capable of taking fish:
- "Bigeye tuna" means the fish of which the scientific name is *Thunnus* obesus:

"Cod-end" means that end part of the net which is normally closed during fishing and is capable of holding fish while in the water; and includes, in respect of a net carried on a vessel—

(i) Up to 10 m overall length, not less than the last 3 m of net:

(ii) Ten to 20 m overall length, not less than the last 5 m of net: (iii) Twenty to 30 m overall length, not less than the last 10 m of net:

(iv) Thirty to 40 m overall length, not less than the last 15 m of net:

- (v) Over 40 m overall length, not less than the last 20 m of net: "Danish seine net" means any net or part thereof (including any warp, rope, chain, material, or device used in conjunction with, or attached to, the net) which has a buoyancy system on the top edge and is weighted on the bottom edge and, without the use of any horizontal net opening device, is operated by surrounding any fish and being drawn over the bed of any waters or through any waters to one or more vessels:
- "Dress", in relation to finfish, means the removal of the head (including the pectoral fins and gill covers), the dorsal fins, the anal fins, the tail, and all internal organs of the thoracic and abdominal cavities; and "dressed" has a corresponding meaning:
- "Fillet", in relation to finfish, means that part of the flesh from either side of the fish from the pectoral fin to the tail (including any skin on that part):
- "Fish packing house" means any premises licensed under the Fish (Packing for Export) Regulations 1977*:
- "Greenweight" means the weight of any fish which is in a whole and unprocessed state:
- "Hake" means the fish of which the scientific name is Merluccius australis:
- "Headed and gutted" means, in relation to finfish, to have had the head (including the pectoral fins and gill covers) and all internal organs of the thoracic and abdominal cavities removed; and, in relation to squid, means to have had the head (including the tentacles) and all internal organs removed:
- "Hoki" means the fish of which the scientific name is *Macruronus* novaezelandiae:
- "Jack mackerel" means the fish of which the scientific name is *Trachurus declivis*:
- "Ling" means the fish of which the scientific name is Genypterus blacodes:
- "Line" or "lines" means any line to which hooks are attached (whether the line is held in the hand or otherwise) which is set, moored, or placed, and that is capable of taking fish:
- "New Zealand fisheries areas" has the same meaning as in the Fisheries (Commercial Quotas) Regulations 1984[†]:
- "Orange roughy" means the fish of which the scientific name is Hoplostethus atlanticus:
- "Oreo dory" means the black oreo dory (Allocyttus sp.), the smooth or small spined oreo dory (Pseudocyttus maculatus), and the spiky oreo dory (Neocyttus rhomboidalis):
- "Others", in relation to the allocation of quotas, means any commercial fishermen other than those specified in clause 3 (1) (a) to (j) and (2) of this notice:

- "Owned", in relation to a fishing vessel, means having the use or disposition of that vessel, whether by ownership, charter, lease, bailment, or other demise of the vessel, and whether formally or informally:
- "Pair trawling" means trawling using a net that is towed or hauled through the water by more than one vessel:
- "Pole and line" means any type of fishing method where a pole is used in conjunction with a line, to which a barbless hook is attached:
- "Purse seining" means the fishing method whereby any net is operated from a vessel to encircle fish, and which is drawn together at the bottom to enclose the fish:
- "Silver warehou" means the fish of which the scientific name is Seriolella punctata:
- "Single trawling" means the use of a trawl net by one vessel: "Skipjack tuna" means the fish of which the scientific name is Katsuwonus pelamis:
- "Southern bluefin tuna" means the fish of which the scientific name is Thunnus maccoyi:
- "Southern Islands Fisheries Area" has the same meaning as in the Fisheries (Commercial Quotas) Regulations 1984*:
- "Surface longlining" means any type of line fishing method which is capable of catching pelagic fish; but does not include pole and line fishing or trolling:
- "Squid" means-
 - (a) The shellfish, commonly known as arrow squid, which has the scientific name Nototodarus sp.; and
 - (b) The shellfish, commonly known as broad squid, which has the scientific name Sepioteuthis bilineata:
- "Squid jigging" means any type of fishing method for taking squid using a line:
- "Trawl net" means any net or part thereof (including any warp, rope, chain, material, or device used in conjunction with, or attached to, the net) which has a buoyancy system on the top edge and is weighted on the bottom edge and is operated by being drawn over the bed of any waters or through any waters by one or more vessels underway:
- "Trawling" means using a trawl net:
- "Trolling" means any fishing method whereby a line is towed through, or on top of, the water:
- "Yellowfin tuna" means the fish of which the scientific name is Thunnus albacares.

(2) Words and expressions in this notice which are defined in the Fisheries Act 1983 or the Fisheries (Commercial Fishing) Regulations 1983† shall, unless the context otherwise requires, have the meanings so defined.

(3) Where, in this notice, an obligation is imposed on a fishing vessel to submit a report, it shall be the duty of the master of the vessel to ensure that that report is so submitted in accordance with the requirements of this notice.

Allocation of Quotas

3. Allocation of quota to specified companies—(1) The total quotas of finfish and squid prescribed in the Fisheries (Commercial Quotas) Regulations 1984* shall be allocated in accordance with subclause (5) of this clause to the following companies and fishermen:

(a) Amaltal Coolstores and Exporters Limited (known as Amaltal):

- (b) Feron Seafoods Limited (known as Feron):
- (c) Fletcher Fishing Limited (known as Fletcher):
- (d) Sanford Limited (known as Sanford):
- (e) Sealord Products Limited (known as Sealord):
- (f) South Island Deepwater Fishing Company Limited (known as South Island Deep Water Fishing or SIDWF):
- (g) Skeggs Foods Limited (known as Skeggs):
- (h) Southland Fish Processors Co-operative Limited (known as Southland Co-op):
- (i) Wanganui Trawlers Limited (known as Wanganui):
- (j) J. Wattie Canneries Limited (known as Watties):
- (k) "Others".
- (2) For the purposes of this notice—
- (a) Amaltal shall be deemed to include Amalsov Fish Ltd., Talleys Fisheries Ltd., and the Amaltal and Taiyo Fishing Partnership:
- (b) Feron shall be deemed to include Nichiro and Feron Fisheries New Zealand Ltd.:
- (c) Fletcher shall be deemed to include Fletcher Sovrybflot Fishing Ltd., and Jaybel Nichimo Fishing Ltd.:
- (d) Sanford shall be deemed to include Sanmar Fisheries Ltd., and the Sanford Limited Joint Venture:
- (e) SIDWF shall be deemed to include Deep Cove Fisheries Ltd., Globe Export Fisheries Ltd., Independent Fisheries Ltd., Kenton Trawling Co. Ltd., Otakou Fisheries Ltd., United Fisheries Ltd., and Wilson Neil Export Services Ltd.:
- (f) Southland Co-op shall be deemed to include Bapobs Ltd., Bluff Seafood Processors Ltd., Johnson's Oysters, Johnson and De Ryk Packing Co. Ltd., Solander Fisheries Ltd., and Stewart Island Canneries Ltd.:
- (g) Wanganui shall be deemed to include Pacific Oyang Ltd., and Oyang Fisheries Company Ltd.:
- (h) Watties shall be deemed to include the Wattie and Taiyo Fishing Partnership, and Wattie Taiyo.

(3) The quotas, to be filled by trawling, shall be filled by vessels owned by the companies and fishermen specified in subclauses (1) and (2) of this clause during the fishing year ending with the 30th day of September 1985.

(4) No New Zealand fishing vessel (being a vessel which, when registered under section 57 of the Act, required the consent of the Director General pursuant to subsection (8) of that section before being so registered) shall be used to fill any part of a quota allocated to "Others" if at any prior time during the fishing season the vessel was used to fill any part of any other quota.

(5) The quotas are hereby allocated as specified in the following table:

² "Rest" for hake, hoki, and oreo dories means New Zealand fisheries waters excluding Areas A, E, and other Areas specified for each species.

s"Rest" for squid means all New Zealand fisheries waters excluding the waters contained in the Southern Islands Fisheries Area and in Area A.

(6) There shall be payable to the Crown by each of the companies listed in paragraphs (a) to (j) of subclause (1) of this clause a royalty of—

- (a) \$70 per tonne (greenweight) of allocation of orange roughy held at 1 October 1984; and
- (b) \$25 per tonne (greenweight) of allocation of hoki held at 1 October 1984; and
- (c) \$15 per tonne (greenweight) of allocations of barracouta, hake, ling, oreo dories, silver warehou, and squid held at 1 October 1984.

(7) There shall be payable to the Crown by each vessel fishing which is included in the "Others" category pursuant to subclause (1) (k) of this clause a royalty of—

- (a) \$70 per tonne (greenweight) of orange roughy caught:
- (b) \$25 per tonne (greenweight) of hoki caught:
- (c) \$15 per tonne (greenweight) of hake, ling, oreo dories, silver warehou, and squid caught—

after the 8th day of November 1984.

4. Use of conversion factors—(1) The Director-General may, for the purposes of converting the weight of processed fish to whole greenweight, use the following conversion factors:

(2) For the purposes of converting to whole greenweight the weight of any fish which has been processed into fish meal, the Director-General may use a conversion factor of 5.556.

(3) Conversion factors may be used to ascertain the tonnage of any fish taken to fill a fish quota.

5. Fishing for barracouta—(1) Notwithstanding any barracouta quota allocated to a company specified under clause 3 (1) (a) to (j) of this notice, no fishing vessel owned by that company shall be used to fill any part of that barracouta quota unless the vessel is of the sort registered as described in clause 3 (4) of this notice.

(2) Company vessels prohibited under subclause (1) of this clause from being used to fill any part of the barracouta quota allocated to the company may be used to take barracouta to fill the quota allocated to "Others".

Closed Areas

6. Areas closed to fishing—(1) No person shall take fish by trawling from any New Zealand fishing vessel over 43 m in overall length in those waters specified in the Schedule to this notice.

(2) No person shall take any fish or aquatic life within 12 nautical miles of the mean low-water mark of each island or rock of the Auckland Islands.

Net Mesh Restrictions

7. Use of 60 mm mesh permitted in certain areas—Notwithstanding any other notice made pursuant to the Fisheries (Commercial Fishing) Regulations 1983 prohibiting the use or possession on board of a trawl net with a mesh size of less than 100 mm, the use of a trawl net with a mesh size of not less than 60 mm is hereby authorised in Area F south of latitude 48°S (except in the territorial sea) during the period commencing with the 1st day of January and ending with the 31st day of May in any year and in Area E, and the carriage on board of such a net is hereby authorised in respect of a vessel in transit to or from those specified areas if the net is stowed during transit in such a manner that it can not readily be made available for use in fishing.

Processing Requirements

8. Companies to process onshore—(1) Those companies specified in clause 3(1)(a) to (j) of this notice shall process not less than 35 percent by weight of their respective aggregate allocations onshore in a fish packing house each fishing year.

(2) Fish landed in a fish packing house pursuant to subclause (1) of this clause shall be processed further than the headed and gutted stage in the fish packing house.

(3) Failure to comply with the provisions of this clause shall constitute an offence against the Fisheries (Commercial Fishing) Regulations 1983, and shall result in a review of any quota allocation.

Reporting Requirements

9. Reporting requirements for sea fishing vessels—Every New Zealand fishing vessel which is permitted to fish in New Zealand fisheries waters using the methods of single or pair trawling, squid jigging, purse seining, or surface or bottom longlining shall report to the Fisheries Control Centre, Ministry of Agriculture and Fisheries, Wellington, as follows:

- (a) Company vessels—All vessels owned by, or holding a fishing permit in the name of, any of the companies specified in clause 3 (1) (a) to (j) of this notice shall supply a daily position report and a weekly catch report; but the Director-General may, by notice in writing to the holder of a fishing permit for any vessel under 21 m overall length, direct that the vessel is not required to supply a daily position report or a weekly catch report, but shall instead supply a trip report:
- (b) "Others" category vessels—All vessels over 21 m overall length fishing in the "Others" category shall supply a daily position report and a weekly catch report, and all vessels under 21 m overall length fishing in that category shall, if so directed by notice in writing by the Director-General, supply a trip report:
- (c) All vessels—The Director-General may, at any time by notice in writing to the holder of any fishing permit permitting the methods of single or pair trawling, squid jigging, purse seining, or surface or bottom longlining, direct that that vessel shall supply a daily catch report or daily position report; but where any vessel is directed to supply a daily catch report or daily position report, any weekly catch report or trip report that the vessel is otherwise obliged to supply, shall not be required.

10. Format of reports—(1) Every vessel required to submit a daily position report, a catch report, a trip report, or a daily catch report shall supply the information specified under each respective heading to the Fisheries Control Centre as follows:

(a) Daily Position Report (POSREP)—Daily position reports are to give the name of the report (i.e. Posrep), the radio call sign and name of the vessel, the date, and the position of the vessel at noon each day, in latitude and longitude to the nearest minute of arc if at sea, or the name of the port if in port. These reports are to be received in the Fisheries Control Centre by noon on the following day and are to be in one of the forms shown in the following examples:

Surface longline and squid jigging fishing vessels shall only be required to report their positions at noon each Tuesday to the Fisheries Control Centre in the above form. If such a fishing vessel moves more than 60 nautical miles from its last reported position before the next weekly report is due, a new noon position must be reported to the Fisheries Control Centre within 24 hours of it being ascertained:

(b) Catch Report (CATREP)—Catch reports are to give the name of the report (i.e. Catrep), the date, the radio call sign and name of the vessel, the Area of New Zealand fisheries waters and the vessel's catch by species from that Area in greenweight tonnes to one decimal point of a tonne for the preceding week from midnight on Sunday to 2359 hours the following Sunday. These reports are to be received in the Fisheries Control Centre by noon on the Tuesday immediately following the catch week and are to be in one of the forms shown in the following example:

(c) Trip Report (TRIPREP)—Trip reports are to give the name of the report (i.e. Triprep), the dates the vessel commenced and ended the trip, the radio call sign and name of the vessel, the Area or Areas of New Zealand fisheries waters fished, and the vessel's catch by species from each Area in greenweight tonnes to one decimal point of a tonne. The reports are to be forwarded to the Fisheries Control Centre before any fish is landed from the vessel, and are to be in the form shown in the following example: Triprep

(d) Daily Catch Report (DAYREP)—Where daily catch reports are required, the reports are to give the name of the report (i.e. Dayrep), the date, the radio call sign and name of the vessel, the Area of New Zealand fisheries waters, and the catches by species for the period from midnight on one day to 2359 hours on the next day are to be received in the Fisheries Control Centre by noon of the next day. Reports are to be in one of the forms shown in the following examples:

(3) A copy of every report supplied to the Fisheries Control Centre shall be kept in a legible and reasonably permanent form on board the vessel which supplied it for a period of at least 6 months after the end of the fishing year to which the report relates.

Revocation

11. Revocation—The Fisheries (Sea Fishing) Notice 1983* is hereby revoked.

Clause 6

The following areas shall be closed to the taking of fish by trawling from any New Zealand registered vessel over 43 m in overall length:

(a) Extended areas, being—

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice updates certain restrictions on deepwater fishing imposed by the Fisheries (Sea Fishing) Notice 1983. The quotas allocated to individual fishermen for the 1984-85 fishing year are set, and the areas and times during which the use of 60 mm mesh is permitted have been changed. The manner of assessing the amount of fish processed onshore has been set on an annual basis rather than the former 3 year average period. Additional reporting requirements for vessels fishing pursuant to the notice have been introduced, and the existing provisions clarified.
