

## THE FISHERIES (SEA FISHING) NOTICE 1984, AMENDMENT NO. 1

PURSUANT to section 89 of the Fisheries Act 1983 and to the Fisheries (Commercial Fishing) Regulations 1983, the Minister of Fisheries hereby gives the following notice.

## NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Sea Fishing) Notice 1984, Amendment No. 1, and shall be read together with and deemed part of the Fisheries (Sea Fishing) Notice 1984\* (hereinafter referred to as the principal notice).
  - (2) This notice shall come into force on the 1st day of June 1985.
- **2. Specified companies**—(1) Clause 3 (2) (a) of the principal notice is hereby amended by inserting, after the words "Amalsov Fish Ltd.,", the words "Amaltal Fishing Co., Ltd.,".
- (2) The said clause 3 ( $\tilde{2}$ ) is hereby further amended by revoking paragraph (f), and substituting the following paragraph:
  - "(f) Southland Co-op shall be deemed to include Bapobs Limited, Bluff Seafood Processors Limited, Johnson and De Rijk Packing Co. Limited, Mossburn Enterprises Limited, Riverton Fishermens Co-op Limited, Solander Fisheries (Bluff) Limited, Stewart Island Fishermens Co-op Limited, and Urwin and Co. Limited:".
- **3. Allocation of quota to specified companies**—Clause 3 of the principal notice is hereby further amended by revoking the table contained in subclause (5), and substituting the table set out in the Schedule to this notice.

**4. Use of conversion factors**—Clause 4 of the principal notice is hereby amended by omitting the table in subclause (1), and substituting the following table:

<sup>&</sup>lt;sup>2</sup> "Rest" for hake, hoki, and oreo dories means New Zealand fisheries waters excluding Areas A and E, and other Areas specified for each species.

<sup>3&</sup>quot;Rest" for squid means all New Zealand fisheries waters excluding the waters contained in the Southern Islands Fisheries Area and in Area A."

## EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 June 1985, amends the Fisheries (Sea Fishing) Notice 1984.

Clause 2 adds the names of further companies to 2 of the groups of companies which are deemed to constitute a specified company to which a fishing quota has been allocated.

Clause 3 revokes the table of allocations for the fishing year commencing on 1 October 1984, and substitutes a new table. The new table corrects the allocation of the ling quota and allocates the additional quota of 5000 tonnes in respect of squid, which additional quota is provided for in the Fisheries (Commercial Quotas) Regulations 1984, Amendment No. 1.

Clause 4 substitutes a new table of conversion factors which may be used in converting the weight of processed fish to whole greenweight.

Clause 5 excludes barracouta from the requirement relating to onshore processing.
