



**THE FISHERIES (CONVERSION FACTORS) NOTICE 1993,
AMENDMENT NO. 1**

PURSUANT to section 3A(2) of the Fisheries Act 1983, the Minister of Fisheries hereby gives the following notice.

—

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (Conversion Factors) Notice 1993, Amendment No. 1, and shall be read together with deemed part of the Fisheries (Conversion Factors) Notice 1993* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Interpretation—Clause 2 of the principal notice is hereby amended by inserting, after the definition of the term “headed and gutted”, the following definitions:

“‘Hoki mince, headed and gutted’ means the state in which—

“(a) The fish has been headed and gutted; and

“(b) The headed and gutted fish has been rendered by a machine into a minced form; and

“(c) The skin and frame have been mealed:

“‘Hoki mince, skin-off fillets’ means the state in which the fish has been skin-off filleted and the skin-off fillets rendered by a machine into a minced form.”

3. Schedule amended—(1) The Schedule to the principal notice is hereby amended—

- (a) By inserting in the column relating to fins, opposite the item relating to ghost shark, the expression “3.00”;
- (b) By omitting from the column relating to skin-off fillets, opposite the item relating to hoki, the expression “3.20”, and substituting the expression “3.15”;
- (c) By omitting from the column relating to fillets, opposite the item relating to orange roughy, the expression “4.00”, and substituting the expression “3.50”:

- (d) By inserting in the column relating to skin-off fillets, opposite the item relating to orange roughly, the expression "3.50";
 - (e) By omitting from note 4 the expressions "2.85" and "2.05", and substituting, respectively, the expressions "2.55" and "2.15";
 - (f) By omitting from note 11 the expression "2.30", and substituting the expression "2.65".
- (2) The Schedule to the principal notice is hereby amended by inserting, after note 4, the following note:

"4A. Hoki mince—The conversion factor for hoki mince, headed and gutted is 2.25 and the conversion factor for hoki mince, skin-off fillets is 3.50."

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, amends the Fisheries (Conversion Factors) Notice 1993 by changing some of the conversion factors for hoki and scampi.

The changes are as follows:

- (a) Definitions of the terms "hoki mince, headed and gutted" and "hoki mince, skin-off fillets" are inserted into the principal notice:
- (b) The conversion factor for skin-on untrimmed hoki fillets is increased from 2.05 to 2.15:
- (c) The conversion factor for skin-on trimmed hoki fillets is reduced from 2.85 to 2.55:
- (d) The new conversion factor for hoki mince, headed and gutted is 2.25 and the new conversion factor for hoki mince, skin-off fillets is 3.50:
- (e) The conversion factor for scampi tails is increased from 2.30 to 2.65.
