



**THE FRESH-WATER FISHERIES (SOUTHLAND)  
REGULATIONS 1941, AMENDMENT NO. 2**

**ORDER IN COUNCIL**

At the Government Buildings at Wellington, this 6th day of  
October, 1943

Present :

THE HON. D. G. SULLIVAN PRESIDING IN COUNCIL

PURSUANT to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

**REGULATIONS**

1. These regulations may be cited as the Fresh-water Fisheries (Southland) Regulations 1941, Amendment No. 2.

2. These regulations shall be read together with and form part of the Fresh-water Fisheries (Southland) Regulations 1941\* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the 6th day of October, 1943.

4. Regulation 5 of the principal regulations is revoked and the following regulation substituted :—

“ 5. The taking of salmon and trout in the waters named in Regulation 6 hereof shall commence in every year on the 21st day of October and cease on the next ensuing first Sunday after Easter Sunday to the intent that the period from the second Monday after Easter Sunday to the 20th day of October (both days inclusive) in every year shall be a close season for salmon and trout in the said waters.”

5. Regulation 6 of the principal regulations is amended by adding the following items thereto :—

“ (4) The streams running into Lake Manapouri ;

“ (5) The streams running into Lake Te Anau, but excluding the Upukororo River and the tributaries of the Upukororo River.”

6. Regulation 8 of the principal regulations is revoked and the following regulation substituted :—

“ 8. During the period from the 1st day of October, 1943, until the 30th day of September, 1944 (both days inclusive), no person shall fish for, take, or kill any acclimatized fish other than trout by any method whatsoever in the waters named in Regulation 9 hereof to the intent that the said period shall be a close season for such fish in the said waters.”

7. Regulation 16 of the principal regulations is amended by revoking the word “ fifteen ” wherever it occurs therein, and substituting the word “ ten ”.

8. Regulation 20 as heretofore amended and Regulations 21 and 22 of the principal regulations are revoked.

9. The Fresh-water Fisheries (Southland) Regulations 1941, Amendment No. 1\* are revoked.

10. It is hereby declared that these regulations, in so far as they affect the date of commencement and duration of the close season for trout, are made pursuant to section 93 of the Fisheries Act, 1908, and on the written application in that behalf of the Southland Acclimatization Society.
