

## THE FRESH-WATER FISHERIES (AUCKLAND) REGULATIONS 1946, AMENDMENT NO. 1

Pursuant to the Fisheries Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

## REGULATIONS

- 1. These regulations may be cited as the Fresh-water Fisheries (Auckland) Regulations 1946, Amendment No. 1.
- 2. These regulations shall be read together with and form part of the Fresh-water Fisheries (Auckland) Regulations 1946\* (hereinafter referred to as the principal regulations).
- 3. These regulations shall come into force on the seventh day after notification in the Gazette of the making thereof.
- 4. The First Schedule to the principal regulations is amended as follows:—
  - (a) By inserting in Column 1 next following the word "Kakahu" and opposite the words "Artificial fly only" in Column 2 the words "Karapiro Lake (any waters thereof within 50 yards of the mouth of any stream)".
  - (b) By inserting in Column 1 next following the word "Omahine" and opposite the words "Artificial fly only" in Column 2 the word "Omaru".
  - (c) By inserting in Column 1 next following the words "Awakino down-stream from Mahoenui Bridge" and opposite the words "Artificial fly, artificial minnow, and spoon" the words "Karapiro Lake (the whole lake except where fishing totally prohibited or where elsewhere in this Schedule restricted)".
  - (d) By deleting from Column 1 the words "Waikato (from the power-house and foot of the spillway at Arapuni to the Horahora Spillway and power-house)".

- (e) By deleting from Column 1 the words "Waikato (from the Horahora Spillway and power-house to its mouth)" and substituting the words "Waikato (from the Karapiro Spillway and power-house to its mouth) ".
- 5. Regulation 16 of the principal regulations is amended by adding thereto the following clauses:
- "(3) No person shall fish from any unmoored boat or shall troll for trout or other acclimatized fish in any part of Lake Karapiro".
- "(4) No person shall fish for trout or other acclimatized fish from any moored boat in any part of Karapiro Lake except in that part of the lake which lies between a line following the power-lines where they cross the lake about a quarter of a mile below the mouth of the Little Waipa Stream and a line drawn across the lake a quarter of a mile above Karapiro Dam."
