PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1951, Amendment No. 12, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1951* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of October 1973.
- 2. Licence fees—The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 8 (1) of the Freshwater Fisheries Regulations 1951, Amendment No. 11), and substituting the First Schedule set out in the Schedule to these regulations.
 - 3. Revocations—The following regulations are hereby revoked:
 - (a) The proviso to regulation 22 of the principal regulations:

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Freshwater Fisheries Regulations 1951, and come into force on 1 October 1973. The effect of the amendment is to institute a new higher scale of licence fees for licences issued in the South Island than for licences issued in the North Island.
