ORDER IN COUNCIL

At the Government House at Wellington this 7th day of September 1981

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to section 83 of the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1951, Amendment No. 18, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1951* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of October 1981.
- **2. Licences and fees**—(1) Regulation 22 of the principal regulations (as amended by regulation 6 (1) of the Freshwater Fisheries Regulations 1951, Amendment No. 17) is hereby amended by omitting the words "third, fourth and fifth", and substituting the words "third and fourth".
- (2) The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 6 (2) of the Freshwater Fisheries Regulations, Amendment No. 17), and substituting the new First Schedule as set out in the Schedule to these regulations.
- (3) Regulation 6 of, and the First Schedule to, the Freshwater Fisheries Regulations 1951, Amendment No. 17 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Freshwater Fisheries Regulations 1951.

Regulation 2 introduces a new scale of freshwater fishery licence fees applicable to both the North and South Islands. Licence fees for the North Island have been increased to bring them into line with those in the South Island.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 10 September 1981. These regulations are administered in the Ministry of Agriculture and Fisheries.
