THE FRESHWATER FISHERIES REGULATIONS 1951, AMENDMENT NO. 2

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL PURSUANT to the Fisheries Act 1908, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Freshwater Fisheries Regulations 1951, Amendment No. 2, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1951* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date

of their notification in the Gazette.

2. (1) Regulation 11 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:—

- "(2) Notwithstanding anything in the last preceding subclause, any whole season licence issued by any acclimatization society shall be available in that part of the Southern Lakes Acclimatization District which lies within the Westland Land District."
- (2) The principal regulations are hereby amended by revoking the Second Schedule, and substituting the Second Schedule set out in the First Schedule to these regulations.
- **3.** The local regulations specified in the Second Schedule to these regulations are hereby revoked.

"LICENCE TO FISH

" The Fisheries Act 1908 and its Amendments

during any portion of the period from the day of 19 .., to the day of 19.. [Insert earliest and latest dates for any part of New Zealand], falling within the open season in the place where the holder is fishing subject to the above-mentioned Acts and to all general and local regulations made thereunder for the time being in force.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

Regulation 2 of these regulations gives to all holders of full season fishing licences issued by acclimatization societies the right to fish without a further licence in those South Westland waters, which, while lying within the Southern Lakes Acclimatization District, are only readily accessible through the district of the Westland Acclimatization Society. It extends a concession hitherto enjoyed only by adult male anglers residing in the Westland District.

Regulation 3 revokes the local fishing regulations that are specified in the Second Schedule to the regulations. The Buller and Grey District Acclimatization Societies, to which some of these regulations relate, have been amalgamated to form the West Coast Acclimatization Society. Matters provided for in the revoked regulations are, in the case of the new district, sufficiently covered in the principal regulations. In the case of the Nelson and Hawke's Bay Districts matters provided for in the revoked regulations are contained in the principal regulations, and in local modifications with respect to limit bag, size limits, methods of fishing, and operation of the open season, now being provided for in Modification Notices by the Minister of Marine, which are being issued at the same time as these regulations.
