**THE FRESHWATER FISHERIES REGULATIONS 1951,
AMENDMENT NO. 5**

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Freshwater Fisheries Regulations 1951, Amendment No. 5, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1951* (hereinafter referred to as the principal regulations).

2. Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "Secretary of Marine" in sub-clause (1).

3. (1) The principal regulations are hereby further amended by inserting, after regulation 28, the following regulations:

"28A. Each acclimatisation society whose district is in the South Island shall pay to the Council of South Island Acclimatisation Societies the sum of 4s. in respect of each whole-season licence issued by the society at the fee specified in the fourth column of the First Schedule hereto.

"28B. (1) The Council of South Island Acclimatisation Societies shall establish a fund to be known as the Fisheries Pool Fund.

"(2) All amounts paid to the Council under regulation 28A of these regulations shall be paid into the Fisheries Pool Fund.

"(3) Money in the Fisheries Pool Fund may be applied by the Council—

"(a) In making grants to acclimatisation societies whose district is in the South Island to be used for the purpose of ranging and management of freshwater fisheries:

“(b) In reimbursing expenditure incurred by the Crown under arrangements made with the Council:

“(c) For any other purpose in relation to freshwater fisheries research, investigation, and management in the South Island, whether by way of grant to individual societies or otherwise,—
and for no other purpose.”

4. The principal regulations are hereby further amended by omitting from regulation 51, and also from regulations 52 and 53, the words “twenty acclimatised fish”, and substituting in each case the words “fifty acclimatised fish”.

5. The principal regulations are hereby further amended by omitting from regulation 54, and also from regulation 55, the expression “9 in.”, and substituting in each case the expression “6 in.”.

6. (1) The principal regulations are hereby further amended by revoking the First Schedule (as substituted by regulation 3 (1) of the Freshwater Fisheries Regulations 1951, Amendment No. 4), and substituting the First Schedule set out in the Schedule to these regulations.

(2) Regulation 3 of the Freshwater Fisheries Regulations 1951, Amendment No. 4, is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 revokes the definition of the term "Secretary of Marine" in regulation 2 (1) of the principal regulations. That definition is now superseded by the definition in section 78 of the Fisheries Act 1908.

Regulation 3 provides that each acclimatisation society in the South Island must pay to the Council of South Island Acclimatisation Societies the sum of 4s. in respect of each whole-season licence issued by the society at the fee of £2 provided for in the new scale of licence fees set out in the Schedule to these regulations. These amounts are to be paid by the Council into a Fisheries Pool Fund, and applied only in making grants to societies for ranging and freshwater fisheries management, in reimbursing expenditure incurred by the Crown under arrangements made with the Council, or for the purposes of freshwater fisheries research, investigation, or management in the South Island.

Regulation 4 increases the limit bag for trout or salmon from 20 to 50, except where local regulations or modification notices fix a lower limit.

Regulation 5 reduces the size limit for trout or salmon from 9 in. to 6 in., except where local regulations or modification notices fix a larger size limit.

Regulation 6 prescribes a new scale of licence fees.
