THE FRESHWATER FISHERIES REGULATIONS 1951, AMENDMENT NO. 6

ORDER IN COUNCIL

At the Government House at Wellington this 29th day of August 1962

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Freshwater Fisheries Regulations 1951, Amendment No. 6, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1951* (hereinafter referred to as the principal regulations).

2. Regulation 26 of the principal regulations is hereby amended by omitting the words "a tenth", and substituting the words "fifteen per cent".

3. The principal regulations are hereby further amended by revoking regulation 28A (as inserted by regulation 3 (1) of the Freshwater Fisheries Regulations 1951, Amendment No. 5), and substituting the following regulation:

"28A. Each acclimatisation society whose district is in the South Island shall pay to the Council of South Island Acclimatisation Societies in respect of each whole-season licence issued by the society at the fee specified in the fourth column of the First Schedule hereto—

"(a) The sum of 6s. in the case of any such licence issued in respect of the open season ending with the 30th day of April 1963:

"(b) The sum of 7s. in the case of any such licence issued in respect of any subsequent open season."

4. Regulation 85 of the principal regulations is hereby amended by inserting, before the words "No person", the words "Except for the purposes of pisciculture".

5. The principal regulations are hereby further amended by inserting in Part XIX, after regulation 116, the following regulation:

"116A. Every acclimatisation society which undertakes legal proceedings in respect of any breach of the Act or of these regulations or of any modification notice issued pursuant to regulation 7 of these regulations or of any other regulations under the Act shall forthwith on the completion of the proceedings forward to the Secretary for Marine a statement of the circumstances giving rise to the proceedings and the result of the proceedings."

6. (1) The principal regulations are hereby further amended by revoking the First Schedule (as substituted by regulation 6 (1) of the Freshwater Fisheries Regulations 1951, Amendment No. 5), and substituting the First Schedule set out in the Schedule to these regulations.

(2) Regulation 6 of the Freshwater Fisheries Regulations 1951, Amendment No. 5, and the Schedule to those regulations are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 increases from one-tenth to 15 per cent the portion of the licence fees payable as a research levy by acclimatisation societies.

Regulation 3 increases the levy payable by South Island societies to the Council of South Island Acclimatisation Societies. The levy is to be 6s. for each licence issued for the 1962–63 open season and 7s. for each licence issued for subsequent seasons.

Regulation 4 makes it lawful to sell acclimatised fish (e.g., fingerlings) for the purposes of pisciculture.

Regulation 5 requires societies that undertake legal proceedings for breaches of Part II of the Fisheries Act 1908 or the Freshwater Fisheries Regulations 1951 or modification notices under those regulations or other regulations under Part II of the Act to send to the Secretary for Marine a statement of the circumstances and the result of the proceedings.

Regulation 6 substitutes a new scale of licence fees. The fees are increased, and there is no difference between the fees payable for licences issued in the North Island and those payable for licences issued in the South Island.
