PURSUANT to sections 48 and 48A of the Conservation Act 1987, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1983, Amendment No. 11, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1983* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1991.

2. Area of availability of licences—Regulation 6 (1) of the principal regulations (as substituted by regulation 2 (1) of the Freshwater Fisheries Regulations 1983, Amendment No. 10) is hereby amended by omitting the words “unless it is issued only for”, and substituting the words “except in”.

3. Second Schedule amended—The Second Schedule to the principal regulations (as substituted by regulation 3 (1) of the Freshwater Fisheries Regulations 1983, Amendment No. 10) is hereby consequentially amended by omitting from the paragraph preceding the first table of fees the words “unless issued only for”, and substituting the words “except in”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 1991, amend regulation 6 (1) of the Freshwater Fisheries Regulations 1983 to ensure that whole season licences and weekly licences issued outside the Eastern Fish and Game Region or the Taupo District cannot be used in that region or district.
