PURSUANT to section 90 of the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1983, Amendment No. 1, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1983* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Interpretation—Regulation 2 (1) of the principal regulations is hereby amended by revoking the definition of the terms "junior licence", "Rotorua District", "Southern Lakes District", "tourist fishing licence", and "trout", and substituting respectively the following definitions:

- " 'Junior licence' means a licence issued to a person under 16 years of age on the 1st day of October of the relevant season; and, within the Rotorua District and the Southern Lakes District, includes children over 16 years of age who are attending school full time as pupils:
- "'Rotorua District' means the Central North Island Wildlife Conservancy as described in the First Schedule to the Central North Island Wildlife Conservancy Council Regulations 1980* excluding the Taupo District:
- " 'Southern Lakes District' means the Southern Lakes Acclimatisation District described in the First Schedule to the Southern Lakes and Southland Acclimatisation Districts Boundaries Amending Order 1959[†]:
- " 'Tourist fishing licence' means a licence issued pursuant to regulation 6A of these regulations to a *bona fide* overseas tourist to fish for acclimatised fish:
- " 'Trout' includes char of any species, and any hybrid of any trout or char; and includes any trout whether alive or dead, and any part of a trout.".

3. Application of regulations—(1) The principal regulations are hereby amended by revoking regulation 3, and substituting the following regulation:

"3. (1) Part VI (Fish Passage), Part VII (Use of Electric Fishing Machines), and Part IX (Faunistic Reserves) of these regulations shall apply throughout New Zealand.

"(2) These regulations (except Part VI and Part VII and Part IX) shall apply throughout New Zealand other than in the Taupo District."

(2) The principal regulations are further amended by omitting the heading "Part IV Fish Passage" appearing after regulation 40, and substituting the heading "Part VI Fish Passage".

4. Area of availability of licences—(1) Regulation 6 of the principal regulations is hereby amended by revoking subclause (5).

(2) The said regulation 6 is hereby further amended by adding the following subclause:

"(7) Notwithstanding subclauses (1), (2), (3), and (4) of this regulation, the holder of any licence for the time being current issued in respect of the Rotorua District may, during the open season in the Hawke's Bay Acclimatisation District, fish for, take, or kill acclimatised fish in the waters or from the bank of the Mohaka River and all its tributaries which lie within the Hawke's Bay Acclimatisation District."

5. Tourist fishing licences—The principal regulations are hereby amended by inserting, after regulation 6, the following regulation:

"6A. (1) Any officer or employee of the Tourist and Publicity Department, or any overseas travel agent authorised as an agent in that behalf by the General Manager of that Department, may from time to time issue to any person visiting or intending to visit New Zealand as a *bona fide* tourist a tourist fishing licence.

"(2) Every tourist fishing licence—

"(a) Shall be in a form approved by the Director-General for the purpose; and

"(b) Shall authorise the holder, during the period specified in the licence (being a period of one month), to take acclimatised fish in any waters in New Zealand that are for the time being open for fishing for acclimatised fish, subject to the provisions of the Act, the Special Act, or any other enactment or notice imposing restrictions or prohibitions on the times, methods, gear, and places of fishing in those waters and on the fish that may be taken in those waters.

"(3) All fees received in respect of tourist fishing licences (after deducting 10 percent of the aggregate fee chargeable for tourist fishing licences issued in respect of any financial year for the expenses incidental to their issue) shall be paid into the Consolidated Account.

"(4) The fees paid for a tourist fishing licence shall be as follows:

"(a) An adult licence	 		 	\$50.00
"(b) A junior licence	 	• •	 	\$10.00."

6. Licence fees—(1) The principal regulations are hereby amended by revoking the Second Schedule, and substituting the new Second Schedule as set out in the Schedule to these regulations.

(2) The fees payable pursuant to item 1 and item 3 of the said Second Schedule shall be payable in respect of a licence issued for any period to take effect on or after the 8th day of November 1984.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations correct some minor drafting errors in the principal regulations, make more specific provision for tourist fishing licences, and increase the general fishing licence fee for districts outside the Rotorua District from \$20 to \$25 for licences taking effect on or from 8 November 1984.

For fees for licences in the Taupo District see the Taupo Fishing Regulations 1983 (S.R. 1983/288).
