PURSUANT to sections 48 and 48A of the Conservation Act 1987, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1983, Amendment No. 15, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1983\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1993.

**2. New Second Schedule substituted**—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 4 (1) of the Freshwater Fisheries Regulations 1983, Amendment No. 14), and substituting the Second Schedule set out in the Schedule to these regulations.

(2) The licences and fees specified in Part II of the Second Schedule to the principal regulations (as substituted by subclause (1) of this regulation) shall have effect and be payable, as the case may be, only in respect of the period commencing with the 1st day of October 1993 and ending with the close of the 30th day of September 1994.

(3) The following provisions shall apply in relation to the licences referred to in Part II of the said Second Schedule:

- (a) A twenty-four hour licence is valid only for 24 hours commencing with the time specified thereon and may be issued only by the Otago Fish and Game Council for use within its region:
- (b) A forty-eight hour licence is valid only for 48 hours commencing with the time specified thereon and may be issued only by the Otago Fish and Game Council for use within its region:
- (c) A three day licence is valid for 3 days commencing with the date of issue and may be issued only by the North Canterbury Fish and Game Council for use within its region:
- (d) A nine day licence is valid for 9 days commencing with the date of issue and may be issued only by the North Canterbury Fish and Game Council for use within its region:
- (e) A six month licence is valid for the period commencing with the 1st day of April 1994 and ending with the close of the 30th day of September 1994, and may be issued only by the Wellington Fish and Game Council for use within its region:
- (f) A young adult whole of season licence may be issued to any person of or over 16 years of age and under 20 years of age, and may be issued only by the following Fish and Game Councils for use within their respective regions:
  - (i) The Nelson/Marlborough Fish and Game Council:
  - (ii) The North Canterbury Fish and Game Council:
  - (iii) The West Coast Fish and Game Council:
  - (iv) The Central South Island Fish and Game Council:
  - (v) The Otago Fish and Game Council:
  - (vi) The Southland Fish and Game Council:
- (g) A new participants whole of season licence may be issued only by the Nelson/Marlborough Fish and Game Council for use within its region.

**3. Revocation**—Regulation 4 of the Freshwater Fisheries Regulations 1983, Amendment No. 14 (S.R. 1993/153) is hereby consequentially revoked.

## PART I

Whole season licences and weekly licences are available throughout New Zealand, except in the Eastern Fish and Game Region or the Taupo District. Monthly licences are available only in the Eastern Fish and Game Region. Day licences are available only in the region of issue.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 October 1993, amend the Freshwater Fisheries Regulations 1983 by—

- (a) Increasing fees payable in respect of general licences (being licences for areas other than the Eastern Fish and Game Region);
- (b) Creating new categories of licences available for the Nelson/Marlborough Fish and Game, North Canterbury Fish and Game, West Coast Fish and Game, Central South Island Fish and Game, Otago Fish and Game, and Southland Fish and Game Regions. These licences are applicable only in respect of the period 1 October 1993 to 30 September 1994.
