PURSUANT to sections 48 and 48A of the Conservation Act 1987, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1983, Amendment No. 17, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1983* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October

1994.

- 2. New Second Schedule substituted—The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 (1) of the Freshwater Fisheries Regulations 1983, Amendment No. 15 and as amended by regulation 2 (1) of the Freshwater Fisheries Regulations 1983, Amendment No. 16), and substituting the Second Schedule set out in the Schedule to these regulations.
- **3. Part season and niche licences**—(1) Subclauses (2) to (7) of this regulation apply in respect of the licences specified in Part II of the Second Schedule to the principal regulations (as substituted by regulation 2 of these regulations) and subclause (8) of this regulation applies in respect of licences specified in Part III of that Schedule.
- (2) A 24-hour licence and a 48-hour licence may be issued only by the Otago Fish and Game Council for use within its region and shall be valid only for the period of 24 hours or 48 hours, as the case may be, specified on the licence.
- (3) A 3-day licence may be issued only by the North Canterbury Fish and Game Council for use within its region and shall be valid only for the period of 3 days specified on the licence.
 - (4) A winter licence may be issued only by—
 - (a) The Wellington Fish and Game Council; and
 - (b) The Taranaki Fish and Game Council—
- for use within their respective regions and shall be valid only for the period commencing on the 1st day of April 1995 and ending with the 30th day of September 1995.
- (5) A young adult whole season licence may be issued to any person of or over 16 years of age and under 20 years of age, and may be issued only by—
 - (a) The Central South Island Fish and Game Council; and
 - (b) The Nelson/Marlborough Fish and Game Council; and
 - (c) The North Canterbury Fish and Game Council; and
 - (d) The Otago Fish and Game Council; and
 - (e) The Southland Fish and Game Council; and
 - (f) The Taranaki Fish and Game Council; and
 - (g) The West Coast Fish and Game Council;—
- but any young adult whole season licence may be used in the region of any of the aforementioned Fish and Game Councils.
- (6) A new participant whole season licence may be issued only by the Nelson/Marlborough Fish and Game Council for use within its region.
- (7) Except as this regulation may otherwise provide, a licence of any of the classes of licences specified in Part II of the Second Schedule to the principal regulations (as so substituted) shall be valid only in respect of the period commencing on the 1st day of October 1994 and ending with the close of the 30th day of September 1995.
- (8) A licence of any of the classes specified in Section B or Section C of Part III of the Second Schedule to the principal regulations (as so substituted) may be issued only by the Eastern Fish and Game Council for use within its region and shall be valid only for the period specified in respect of that class in that Section.
- **4. Revocations**—The following regulations are hereby consequentially revoked:

PART I

Whole Season, Weekly, and Day General Licences

Whole season licences and weekly licences are available throughout New Zealand, except in the Eastern Fish and Game Region or the Taupo District. Monthly licences are available only in the Eastern Fish and Game Region. Day licences are available only in the region of issue.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 1994, amend the Freshwater Fisheries Regulations 1983. The principal changes, which do not affect the Eastern Fish and Game Region or the Taupo District, are as follows:

- (a) The adult whole season licence fee is increased from \$55 to \$56.00:
- (b) The adult weekly licence fee is increased from \$22 to \$22.50:
- (c) The junior day licence fee is increased from \$3 to \$3.50:
- (d) The adult 6-month licence fee is increased from \$33 to \$33.50: (e) The adult 3-day licence fee is increased from \$16.50 to \$17:
- (f) The adult new participant whole season licence fee is increased from \$27.50 to \$28.00:
- (g) The junior adult whole season licence fee is increased from \$27.50 to \$28:
- (h) The junior 24-hour licence fee is increased from \$3 to \$3.50:
- (i) The 9-day licence is no longer available.
