PURSUANT to the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Freshwater Fisheries Regulations 1983, Amendment No. 5, and shall be read together with and deemed part of the Freshwater Fisheries Regulations 1983* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Fees exclusive of goods and services tax—The principal regulations are hereby amended by inserting, after regulation 14, the following regulation:

- "14A. The licence fees set out in the Second Schedule to these regulations are exclusive of goods and services tax under the Goods and Services Tax Act 1985."
- **3.** Increase in licence fees—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 6 (1) of the Freshwater Fisheries Regulations 1983, Amendment No. 4), and substituting the new Second Schedule set out in the Schedule to these regulations.
- (2) Regulation 6 of, and the Schedule to, the Freshwater Fisheries Regulations 1983, Amendment No. 4 are hereby consequentially revoked.

Freshwater Fisheries Regulations 1983, Amendment No. 5

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in the Gazette, increase the fees for general licences and for Southern Lakes Districts Licences. The fees are increased by the following amounts:

- (a) Adult whole season licences—\$3.00:
- (b) Adult weekly licences—\$1.73:
- (c) Adult daily licences-\$0.77:
- (d) Junior whole season licences—\$0.77:
- (e) Junior daily licences—\$0.27.

The fees are exclusive of goods and services tax.
