## THE FISHERIES (COMMERCIAL FISHING) REGULATIONS 1986, AMENDMENT NO. 16

#### ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 89 of the Fisheries Act 1983, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (Commercial Fishing) Regulations 1986, Amendment No. 16, and shall be read together with and deemed part of the Fisheries

(Commercial Fishing) Regulations 1986\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date

of their notification in the Gazette.

2. Fees—(1) Part I of the Second Schedule to the principal regulations (as substituted by regulation 3 (1) of the Fisheries (Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended by revoking clause 1, and substituting the following clause:

- (2) Part IV of the Second Schedule to the principal regulations (as so substituted) is hereby amended by adding the following clause:
- "5. Automatic location communicators—(1) The fee payable in respect of the grant of a type approval for an automatic location communicator shall be calculated as follows:
  - "(a) Labour supplied by the Ministry in respect of the approval shall be charged at the rate of \$50.00 per hour:
  - "(b) The actual and reasonable costs incurred by the Ministry in respect of equipment and materials supplied or used in relation to the approval shall be added to the amount payable under paragraph (a) of this subclause.

"(2) The fee payable in respect of the registration of an automatic

location communicator is \$180.00.

"(3) The fee payable in respect of the supply of an extract from the public register of automatic location communicators is \$18.00."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after the date of their notification in the *Gazette*, impose new fees in relation to fishing vessels required to carry and operate automatic location communicators.

The new fees are as follows:

- (a) The registration fee for New Zealand-owned fishing vessels required to carry and operate an automatic location communicator is increased from \$75 to \$1,611:
- (b) The registration fee for foreign chartered fishing vessels that are required to carry and operate an automatic location communicator is increased from \$2,061 to \$3,591:
- (c) The fee for the granting of a type approval in respect of an automatic location communicator comprises labour at the rate of \$50 per hour and the costs of equipment and material:
- (d) The fee for the registration of an automatic location communicator is \$180:
- (e) The fee for the supply of an extract from the register of automatic location communicators is \$18.
