PURSUANT to section 89 of the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

## REGULATIONS

1. Title, commencement, and application—(1) These regulations may be cited as the Fisheries (Commercial Fishing) Regulations 1986, Amendment No. 22, and shall be read together with and deemed part of the Fisheries (Commercial Fishing) Regulations 1986\* (hereinafter referred to as the principal regulations).

- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*, and shall apply in respect of vessels registered on or after that date.
- 2. Vessel registration fees—(1) Part I of the Second Schedule to the principal regulations (as substituted by regulation 3 (1) of the Fisheries (Commercial Fishing) Regulations 1986, Amendment No. 14) is hereby amended by revoking clause 1 (as substituted by regulation 2 (1) of the Fisheries (Commercial Fishing) Regulations 1986, Amendment No. 16), and substituting the following clause:

"1. The fees payable in respect of registration of a fishing vessel and the issue of duplicates shall be as follows:	
"(a) Where the vessel is New Zealand-owned and is required by or under the Fisheries (Satellite Vessel Monitoring) Regulations 1993* to carry and operate an automatic location communicator:	
(i) Registration	3,450.00
(ii) Issue of duplicate certificate of registry	15.00
"(b) Where the vessel is New Zealand-owned but is not required by or under the Fisheries (Satellite Vessel Monitoring) Regulations 1993* to carry and operate an automatic location communicator:	
"(i) Registration	75.00
"(ii) Issue of duplicate certificate of registry	15.00
"(c) Where the vessel is foreign-owned and the chief executive has given consent for registration pursuant to section 57 (8) of the Act, and the vessel is required by or under the Fisheries (Satellite Vessel Monitoring) Regulations 1993* to carry and operate an automatic location communicator:	
"(i) Registration	5,436.00
"(ii) Issue of duplicate certificate of registry	15.00
"(d) Where the vessel is foreign-owned and the chief executive has given consent for registration pursuant to section 57 (8) of the Act, but the vessel is not required by or under the Fisheries (Satellite Vessel Monitoring) Regulations 1993* to carry and operate an automatic location communicator:	
"(i) Registration	2,061.00
"(ii) Issue of duplicate certificate of registry	15.00"

(2) Part IV of the Second Schedule to the principal regulations (as so substituted) is hereby amended by revoking paragraph (b) of clause 6 (2) (as added by regulation 6 of the Fisheries (Commercial Fishing) Regulations 1986, Amendment No. 17), and substituting the following paragraph:

"(b) In the case of a ship required to carry an automatic location

communicator, \$3,780.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in the Gazette, amend the Fisheries (Commercial Fishing) Regulations 1986 to—

- (a) Increase from \$1,611 to \$3,450 the fee for registration of New Zealand-owned vessels required by the Fisheries (Satellite Vessel Monitoring) Regulations 1993 to carry automatic location communicators; and
- (b) Increase from \$3,591 to \$5,486 the fee for registration of foreign-owned vessels required by the Fisheries (Satellite Vessel Monitoring) Regulations 1993 to carry automatic location communicators; and
- (c) Increase from \$3,501 to \$3,780 the application fee for consents for non-New Zealand ships to possess fish, aquatic life, or seaweed pursuant to section 61 of the Fisheries Act 1983, where those ships are required by the Fisheries (Satellite Vessel Monitoring) Regulations 1993 to carry automatic location communicators.
