



THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1986, AMENDMENT NO. 13

PURSUANT to section 280B of the Fisheries Act 1983, the Minister of Fisheries, after having regard to the matters specified in section 28D of that Act, hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 13, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of October 1995.

2. Total allowable commercial catch for blue cod decreased—The First Schedule to the principal notice is hereby amended by omitting item D of the item relating to blue cod (as substituted by clause 2 of the

3. Total allowable commercial catch for blue moki increased—

The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to blue moki (as substituted by clause 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 11), and substituting the following item:

“A. Auckland (East), Auckland (West), Central 1, 2, 7, 8, 400”.

Challenger/Central (Plateau) combined

4. Total allowable commercial catch for elephant fish increased

—The First Schedule to the principal notice is hereby amended by omitting item D of the item relating to elephant fish (as substituted by clause 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 5), and substituting the following item:

“D. South-East (Coast) and
South-East (Chatham Rise) combined ... 3 & 4 500”.

5. Total allowable commercial catch for hoki increased—

The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to hoki (as substituted by clause 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 12), and substituting the following item:

“A. Auckland (East), Auckland (West), Central 1, 2, 3, 240 000”.
(East), Central (Egmont), Challenger/Central 4, 5, 6,
(Plateau), South-East (Coast), South-East 7, 8, & 9
(Chatham Rise), Southland, and Sub-
Antarctic combined

6. Total allowable commercial catch for orange roughy varied—

The First Schedule to the principal notice is hereby amended by omitting the item relating to orange roughy (as substituted by clause 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 12), and substituting the following item:

7. Total allowable commercial catch for red cod increased—The First Schedule to the principal notice is hereby amended by omitting item B of the item relating to red cod, and substituting the following item:

“B. Central (East) and Central (Egmont) 2 & 8 500”
combined

8. Total allowable commercial catch for snapper decreased—The First Schedule to the principal notice is hereby amended by omitting items A, B, and D of the item relating to snapper (as substituted by clause 7 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 10), and substituting the following items:

“A. Auckland (East) 1 3 000
B. Auckland (West) and Central (Egmont) 8 & 9 1 500
combined
D. Central (East) 2 252.3”.

9. Revocations—The following provisions are hereby revoked:

- (a) Clause 7 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 10;
- (b) Clauses 2 and 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 11;
- (c) Clauses 3 and 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 12.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 October 1995, amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986.

The changes are as follows:

- (a) The TACC for blue cod is decreased, in the case of area 7, from 95 greenweight tonnes to 70 greenweight tonnes;
- (b) The TACC for blue moki is, in the case of areas 1, 2, 7, 8, and 9, increased from 200 greenweight tonnes to 400 greenweight tonnes;
- (c) The TACC for elephant fish is increased, in the case of areas 3 and 4, from 400 greenweight tonnes to 500 greenweight tonnes;
- (d) The TACC for hoki is increased, in the case of areas 1, 2, 3, 4, 5, 6, 7, 8, and 9, from 220,000 greenweight tonnes to 240,000 greenweight tonnes;
- (e) The TACC for orange roughy is—
 - (i) In the case of areas 1, 8, and 9, increased from 190 greenweight tonnes to 1,190 greenweight tonnes; and
 - (ii) In the case of area 2A, decreased from 6,999.73 greenweight tonnes to 4,261.2 greenweight tonnes; and
 - (iii) In the case of area 2B, decreased from 820.23 greenweight tonnes to 258.6 greenweight tonnes; and
 - (iv) In the case of area 3A, decreased from 1,840.04 greenweight tonnes to 580.2 greenweight tonnes; and
 - (v) In the case of area 7B, decreased from 1,558 greenweight tonnes to 430 greenweight tonnes; and
 - (vi) In the case of areas 3B, 4, 5A, and 6, decreased from 14,000 greenweight tonnes to 12,700 greenweight tonnes;
- (f) The TACC for red cod is increased, in the case of areas 2 and 8, from 350 greenweight tonnes to 500 greenweight tonnes;
- (g) The TACC for snapper is—
 - (i) In the case of area 1, decreased from 4,900 greenweight tonnes to 3,000 greenweight tonnes; and
 - (ii) In the case of area 2, increased from 250 greenweight tonnes to 252.3 greenweight tonnes (which increase accords with a decision of the Quota Appeal Authority).
