

THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1986, AMENDMENT NO. 10

PURSUANT to section 280B of the Fisheries Act 1983, the Minister of Fisheries, acting after allowing for the matters specified in section 28D of that Act, hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 10, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986* (hereinafter referred to as the principal notice).
 - (2) This notice shall come into force on the 1st day of October 1992.
- 2. Total allowable commercial catch for blue moki increased—The First Schedule to the principal notice is hereby amended by omitting item B of the item relating to blue moki, and substituting the following item:
- "B. South-East (Coast) 3 120".
- **3.** Total allowable commercial catch for bluenose increased—The First Schedule to the principal notice is hereby amended by omitting item E of the item relating to bluenose, and substituting the following item:
- "E. South-East (Coast), South-East (Chatham 3, 4, 5, 350".

Total allowable commercial catch for orange roughy decreased—The First Schedule to the principal notice is hereby amended by omitting item G of the item relating to orange roughy (as substituted by clause 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 8), and substituting the following item:
- "G. South-East (Strathallan), South-East 3B, 4, 5A, 21 300". (Chatham Rise), and South-East and 6 (Otago)/Southland, and Sub-Antarctic combined
- 5. Total allowable commercial catch for oreo dories increased— The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to oreo dories, and substituting the following item:
- "A. Auckland (East), Auckland (West), Central 1, 2A, 2B, 6 040".

- **6. Total allowable commercial catch for paua decreased**—The First Schedule to the principal notice is hereby amended by omitting item E of the item relating to paua, and substituting the following item:

"E. South-East (Otago and Southland Coast) PAU 5 443".

7. Total allowable commercial catch for snapper increased—The First Schedule to the principal notice is hereby amended by omitting items A, B, and D of the item relating to snapper, and substituting, respectively, the following items:

Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 10

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 October 1992, amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986 by amending the prescribed total allowable commercial catches (TACC) for some species as follows:

- (a) The TACC for blue moki in area 3 is increased from 60 to 120 tonnes:
- (b) The TACC for bluenose in areas 3, 4, 5, and 6 is increased from 150 to 350 tonnes:
- (c) The TACC for orange roughy in areas 3B, 4, 5A, and 6 is decreased from 23 787 to 21 300 tonnes:
- (d) The TACC for oreo dories in areas 1, 2A, 2B, 5A, 7A, 7B, 8, and 9 is increased from 4 000 to 6 040 tonnes:
- (e) The TACC for paula in area 5 is decreased from 445 to 443 tonnes:
- (f) The TACC for snapper is altered as follows:

 - (i) In area 1, it is increased from 4 710 to 4 900 tonnes: (ii) In areas 8 and 9, it is increased from 1 330 to 1 500 tonnes:
 - (iii) In area 2, it is increased from 130 to 250 tonnes.

The areas referred to are described in the principal notice and tonnages are greenweight.
