

## THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1986, AMENDMENT NO. 11

PURSUANT to section 280B of the Fisheries Act 1983, the Minister of Fisheries, acting after allowing for the matters specified in section 28D of that Act, hereby gives the following notice.

## NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 11, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986\* (hereinafter referred to as the principal notice).
  - (2) This notice shall come into force on the 1st day of October 1993.
- 2. Total allowable catch for blue cod decreased—The First Schedule to the principal notice is hereby amended by omitting item D of the item relating to blue cod (as substituted by regulation 2 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 3), and substituting the following item:
- "D. Challenger/Central (Plateau)

7 95".

**3. Total allowable catch for blue moki increased**—The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to blue moki, and substituting the following item:

"A. Auckland (East), Auckland (West), Central 1, 2, 7, 8 200".

4. Total allowable catch for orange roughy decreased—The First Schedule to the principal notice is hereby amended by omitting item D of the item relating to orange roughy (as substituted by regulation 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 5), and substituting the following item:

"D. Central/Challenger/South-East (Cook Strait/ 3A 2 300". Kaikoura)

**5. Total allowable catch for stargazer increased**—The First Schedule to the principal notice is hereby amended by omitting item C of the item relating to stargazer, and substituting the following item:

"C. Central (Egmont) 8 50".

## EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 October 1993, amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986. The changes are as follows:

(a) The TACC for blue cod in area 7 is decreased from 110 to 95 tonnes:

- (b) The TACC for blue moki in areas 1, 2, 7, 8, and 9 is increased from 130 to 200 tonnes:
- (c) The TACC for orange roughy in area 3A is decreased from 2689 to 2300 tonnes:
- (d) The TACC for stargazer in area 8 is increased from 20 to 50 tonnes.
