



**THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL  
ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE  
1986, AMENDMENT NO. 12**

PURSUANT to section 280B of the Fisheries Act 1983, the Minister of Fisheries, acting after allowing for the matters specified in section 28D of that Act, hereby gives the following notice.

NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 12, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986\* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of October 1994.

**2. Total allowable commercial catch for bluenose increased**—The First Schedule to the principal notice is hereby amended by omitting items C and D of the item relating to bluenose, and substituting the following items:

“C. Central (Egmont) .. .. .	8	100
“D. Challenger/Central (Plateau) .. .. .	7	150”.

**3. Total allowable commercial catch for hoki increased**—The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to hoki (as substituted by clause 2 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 8), and substituting the following item:

**4. Total allowable commercial catch for ling increased**—The First Schedule to the principal notice is hereby amended by omitting items D and E of the item relating to ling, and substituting the following items:

**5. Total allowable catch for orange roughy increased in 1 area and decreased in others**—The First Schedule to the principal notice is hereby amended by omitting the item relating to orange roughy (as substituted by clause 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 5), and substituting the following item:

EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on 1 October 1994, amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986.

The changes are as follows:

- (a) The TACC for bluenose is increased—
  - (i) In the case of area 7, from 60 to 150 tonnes:
  - (ii) In the case of area 8, from 20 to 100 tonnes:
- (b) The TACC for hoki in area 1 is increased from 201 877 to 220 000 tonnes:
- (c) The TACC for ling is increased—
  - (i) In the case of area 3, from 1 850 to 2 800 tonnes:
  - (ii) In the case of area 4, from 4 300 to 5 720 tonnes:
- (d) The TACC for orange roughy in area 2<sub>A</sub> is increased from 5 500 to 6 999.73 tonnes:
- (e) The TACC for orange roughy in areas 2<sub>B</sub>, 3<sub>A</sub>, and 3<sub>B</sub> is reduced—
  - (i) In the case of area 2<sub>B</sub>, from 1 053 to 820.23 tonnes:
  - (ii) In the case of area 3<sub>A</sub>, from 2 300 to 1 840.04 tonnes:
  - (iii) In the case of area 3<sub>B</sub>, from 21 300 to 14 000 tonnes.
