NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 14, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of October 1996.

2. Total allowable catch for barracouta increased—The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to barracouta, and substituting the following item:

“A. Auckland (East), Central (East), and South-East (Coast) combined 1, 2, & 3 11,000”.

3. Total allowable catch for bluenose increased—The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to bluenose, and substituting the following item:

“A. Auckland (East), and Auckland (West) combined 1 & 9 1,000”.

4. Total allowable catch for gemfish decreased—The First Schedule to the principal notice is hereby amended by omitting items C & D of the item relating to gemfish, and substituting the following items:

“C Central (Egmont) and Challenger/Central (Plateau) combined 7 & 8 900

“D South-East (Coast), South-East (Chatham Rise), Southland, and Sub-Antarctic combined 3, 4, 5, & 6 1,500”.

5. Total allowable catch for hoki increased—The First Schedule to the principal notice is hereby amended by omitting item A of the item relating to hoki (as substituted by clause 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 13), and substituting the following item:

“A. Auckland (East), Auckland (West), Central (East), Central (Egmont), Challenger/Central (Plateau), South-East (Coast), South-East (Chatham Rise), Southland, and Sub-Antarctic combined 1, 2, 3, 4, 5, 6, 7, 8, & 9 250,000”.

6. Total allowable catch for oreo dories varied—The First Schedule to the principal notice is hereby amended by omitting items B and D of the item relating to oreo dories and substituting the following items:

“B. Central/Challenger/South-East (Cook Strait/Kaikoura) and South-East (Strathallan) combined 3A & 3B 6,600

“D. Sub-Antarctic 6 6,000”.

7. Total allowable catch for gurnard increased—The First Schedule to the principal notice is hereby amended by omitting items D and E of the item relating to gurnard (as substituted by clause 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 9), and substituting the following items:

“D. Challenger/Central (Plateau) 7 815.3

- “E. South-East (Coast), South-East, (Chatham 3, 4, 5, & 900”.
Rise), Southland, and Sub-Antarctic 6
combined

8. Revocations—The following provisions are hereby revoked:

- (a) Clause 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 13:
- (b) Clause 3 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 9.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 October 1996, amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986.

The changes are as follows:

- (a) The TACC for barracouta is increased in the case of areas 1, 2, and 3 combined to 11,000 greenweight tonnes:
- (b) The TACC for bluenose is increased in the case of areas 1 and 9 combined to 1,000 greenweight tonnes:
- (c) The TACC for gemfish is decreased in the case of areas 3, 4, 5, and 6 combined to 1,500 greenweight tonnes, and in the case of areas 7 and 8 combined, to 900 greenweight tonnes:
- (e) The TACC for hoki is increased in the case of areas 1, 2, 3, 4, 5, 6, 7, 8, and 9 combined to 250,000 greenweight tonnes:
- (f) The TACC for oreo dories is decreased in the case of areas 3A and 3B combined to 6,600 greenweight tonnes and increased in the case of area 6 to 6,000 greenweight tonnes:
- (g) The TACC for gurnard is increased in the case of areas 3, 4, 5, and 6 combined to 900 greenweight tonnes.
