THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1986, AMENDMENT NO. 3

PURSUANT to section 28c of the Fisheries Act 1983, the Minister of Fisheries, acting after allowing for the matters specified in that section, hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 3, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Total allowable catch for blue cod and school shark increased—(1) The First Schedule to the principal notice is hereby amended by omitting the item relating to blue cod, and substituting the following item:

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice (which comes into force on the day after the date of its notification in the *Gazette*) amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986.

The notice increases the total allowable catch for blue cod in the South-East (Chatham Rise) Area from 410 to 600 greenweight tonnes, and increases the total allowable catch for school shark in the South-East (Chatham Rise) Area from 120 to 200 greenweight tonnes.
