## THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1986, AMENDMENT NO. 5

PURSUANT to section 28C of the Fisheries Act 1983, the Minister of Fisheries, acting after allowing for the matters specified in that section, hereby gives the following notice.

## NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 5, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986\* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of October 1988.

2. Total allowable catch for alfonsino increased—The First Schedule to the principal notice is hereby amended by omitting the item relating to alfonsino, and substituting the following item:

## EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice (which comes into force on 1 October 1988) amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986.

The notice increases the total allowable catch for certain species as follows:

- (i) The total allowable catch for alfonsino in the South-East (Coast), South-East (Chatham Rise), Southland and Sub-Antarctic combined area is increased from 220 to 1 000 greenweight tonnes.
- (ii) The total allowable catch for elephant fish in the South-East (Coast) and South-East (Chatham Rise) combined area is increased from 280 to 400 greenweight tonnes.
- (iii) The total allowable catch for john dory in the Auckland (East) and Auckland (West) combined area is increased from 510 to 600 greenweight tonnes.
- (iv) The total allowable catch for orange roughy in the Auckland (East), Auckland (West), and Central (Egmont) combined area is increased from 10 to 190 greenweight tonnes.
