

THE FISHERIES (QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1986, AMENDMENT NO. 7

Pursuant to section 280B of the Fisheries Act 1983, the Minister of Fisheries, acting after allowing for the matters specified in section 28D of that Act, hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 7, and shall be read together with and deemed part of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986* (hereinafter referred to as the principal notice).
- (2) This notice shall come into force on the day after the date of its notification in the *Gazette*.
- 2. Total allowable commercial catch for alfonsino decreased—The First Schedule to the principal notice is hereby amended by omitting item B of the item relating to alfonsino (as substituted by clause 2 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 5), and substituting the following item:

"B. Central (East) 2 1 250".

3. Total allowable commercial catch for orange roughy decreased—The First Schedule to the principal notice is hereby amended by omitting items F and G of the item relating to orange roughy (as substituted by clause 5 of the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 5 and clause 2 of the Fisheries (Quota Management Areas, Total Allowable

- **5. Revocation**—The Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986, Amendment No. 6 is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the Gazette, amends the Fisheries (Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1986 by decreasing the total allowable commercial catches for certain species of fish as follows:

- (a) The total allowable commercial catch for alfonsino in the Central (East) Area 2 is reduced from 1 510 tonnes to 1 250 tonnes.
- (b) The total allowable commercial catch for orange roughy in the Challenger (North) Area 7A is reduced from 12 000 tonnes to 2 500 tonnes. This reduction will be met in part by the cancellation of Crown quota as required by section 280D of the Fisheries Act 1989.
- (c) The total allowable catch for orange roughy in the combined South-East, Southland, and Sub-Antarctic area (Areas 3B, 4, 5A, and 6) is reduced from 32 487 tonnes to 28 787 tonnes.
- (d) The total allowable commercial catch for snapper in the Challenger/Central (Plateau)

 Area 7 is reduced from 330 tonnes to 160 tonnes.
